STEWARDS RULING

Ruling number: 15-0077
LGC Sample #0058221

Track: Churchill Downs

Date: May 25, 2015

Upon receipt of notification from LGC Science, Inc., the official testing laboratory for the Kentucky Horse Racing Commission, and confirmed at Industrial Laboratories, sample number 0058221 taken from WHYRUAWESOME, who finished first in the second race at Keeneland on April 8, 2015 contained methocarbamol (Class C drug) at a level of 1.6 ng/ml in blood (2nd offense in 365 days). After a formal hearing before the Board of Stewards you are hereby suspended TWENTY (20) days, June 8, 2015 through June 27, 2015 (inclusive) and fined FIFTEEN HUNDRED (\$1500.00) DOLLARS. WHYRUAWESOME is disqualified and all purse money forfeited. Pari-mutuel wagering is not affected by this ruling. During her suspension Ms. Smith is denied the privileges of all facilities under the jurisdiction of the Kentucky Horse Racing Commission. Entry of all horses owned or trained by Ms. Smith is denied pending transfer to persons acceptable to the stewards. Upon receipt of this ruling, you are required within thirty (30) days to pay any and all fines imposed to the Kentucky Horse Racing Commission. Failure to do so will subject you to summary suspension of your license pursuant to 810 KAR 1:025 Section 14 (cc).
