### STEWARDS RULING

**Ruling number: 15-0150**  
**LGC Sample #0075559**

**Track: Turfway Park**

**Date: December 13, 2015**

**Owner/Trainer: Bernard S. Flint**

Upon receipt of notification from LGC Science, Inc., the official testing laboratory for the Kentucky Horse Racing Commission, and confirmed at Texas A & M Veterinary Medical Diagnostic Laboratory, sample number 0075559 taken from STAGE STREET, who finished second in the first race at Churchill Downs on September 19, 2015 contained phenylbutazone at a level of 6.5 ug/ml in blood (Class C drug)(2<sup>nd</sup> offense in 365 days). After a formal hearing before the Board of Stewards you are hereby suspended TWENTY (20) days, December 22, 2015 through January 10, 2016 (inclusive) and fined TWO THOUSAND (\$2000.00) DOLLARS. STAGE STREET is disqualified and all purse money forfeited. Pari-Mutuel wagering is not affected by this ruling. During his suspension Mr. Flint is denied the privileges of all facilities under the jurisdiction of the Kentucky Horse Racing Commission. Entry of all horses owned or trained by Mr. Flint is denied pending transfer to persons acceptable to the stewards. Upon receipt of this ruling, you are required within thirty (30) days to pay any and all fines imposed to the Kentucky Horse Racing Commission. Failure to do so will subject you to summary suspension of your license pursuant to 810 KAR 1:025 Section 14 (cc).
