Upon receipt of notification from LGC Science, Inc., the official testing laboratory for the Kentucky Horse Racing Commission, and confirmed at Texas A & M Veterinary Medical Diagnostic Laboratory (TVMDL Sample Laboratory number D163000565), sample number 0082410 taken from LITTLE NORWEGIAN, who finished first in the first race at Churchill Downs on September 16, 2016 contained 3-hydroxylidocaine at a level of 235 pg/ml in blood (Class B drug). After waiving your right to a formal hearing before the Board of Stewards you are hereby suspended THIRTY (30) days, January 1, 2017 through January 30, 2017 (inclusive) and fined FIVE HUNDRED (\$500.00) DOLLARS. LITTLE NORWEGIAN is disqualified and all purse money forfeited. Pari-mutuel wagering is not affected by this ruling. During his suspension Mr. Foley is denied the privileges of all facilities under the jurisdiction of the Kentucky Horse Racing Commission. Entry of all horses owned or trained by Mr. Foley is denied pending transfer to persons acceptable to the stewards. Upon receipt of this ruling, you are required within thirty (30) days to pay any and all fines imposed to the Kentucky Horse Racing Commission. Failure to do so will subject you to summary suspension of your license pursuant to 810 KAR 1:025 Section 14 (cc).
