## STEWARDS RULING

Owner/Trainer: Brian D. Michael (D.O.B. 1/19/1969)

Upon receipt of notification from LGC Science, Inc., the official testing laboratory for the Kentucky Horse Racing Commission, sample number 0097620 taken from HOLLYWOOD TALENT, who finished second in the sixth race at Turfway Park Park on January 21, 2017 contained MULTIPLE NSAIDS; phenylbutazone (.68 ug/ml in blood) and flunixin (5.8 ng/ml in blood). The concentrations of both permitted NSAIDS are below the primary threshold and above the secondary threshold (second offense in 365 days). After waiving your right to a formal hearing before the Board of Stewards you are hereby suspended FIVE (5) days, February 6, 2017 through February 10, 2017 (inclusive) and fined FIVE HUNDRED (\$500.00) DOLLARS. Purse monies and pari-mutuel wagering are not affected by this ruling. During his suspension Mr. Michael is denied the privileges of all facilities under the jurisdiction of the Kentucky Horse Racing Commission. Entry of all horses owned or trained by Mr. Michael is denied pending transfer to persons acceptable to the stewards. Upon receipt of this ruling, you are required within thirty (30) days to pay any and all fines imposed to the Kentucky Horse Racing Commission. Failure to do so will subject you to summary suspension of your license pursuant to 810 KAR 1:025 Section 14 (cc).
