## STEWARDS RULING

**Ruling number: 17-0102**

Upon receipt of notification from LGC Science, Inc., the official testing laboratory for the Kentucky Horse Racing Commission, and confirmed at UIC Animal Forensic Toxicology Laboratory, sample number 0100787 taken from BETTING MCCANN CAN, who finished tenth in the eleventh race at Churchill Downs on September 23, 2017 contained isoflupredone at a level of 448 pg/ml in blood (Class C drug). After waiving your right to a formal hearing before the Board of Stewards, BETTING MCCANN CAN is disqualified and all purse money forfeited. Pari-mutuel wagering is not affected by this ruling. All purse monies must be returned to the association. The purse of this race is ordered redistributed as follows:
