Upon receipt of notification from LGC Science, Inc., the official testing laboratory for the Kentucky Horse Racing Commission, sample number 00112712 taken from TETRADRACHM, who finished first in the first race at Turfway Park on March 16, 2018 contained MULTIPLE NSAIDS; phenylbutazone (.78 ug/ml in blood) and flunixin (4.1 ng/ml in blood). The concentrations of both permitted NSAIDS are below the primary threshold and above the secondary threshold (2nd offense in 365 days). After waiving your right to a formal hearing before the Board of Stewards you are hereby suspended SEVEN (7) DAYS, April 15, 2018 through April 21, 2018 (inclusive) and fined SEVEN HUNDRED FIFTY (\$750.00) DOLLARS. During his suspension Mr. Crawford is denied the privileges of all facilities under the jurisdiction of the Kentucky Horse Racing Commission. Entry of all horses owned or trained by Mr. Crawford is denied pending transfer to persons acceptable to the stewards. Purse monies and pari-mutuel wagering are not affected by this ruling. Upon receipt of this ruling, you are required within thirty (30) days to pay any and all fines imposed to the Kentucky Horse Racing Commission. Failure to do so will subject you to summary suspension of your license pursuant to 810 KAR 1:025 Section 14 (cc).
