STEWARDS RULING

Upon receipt of notification from Industrial Laboratories, the official testing laboratory for the Kentucky Horse Racing Commission, sample number E370754 taken from FIDES RATIO (FR), who finished fourth in the eighth race at Turfway Park on March 13, 2020 contained Gabapentin in blood (Class B). After waiving his right to a formal hearing before the Board of Stewards Danny W. Turner is hereby suspended THIRTY (30) days and fined FIVE HUNDRED (\$500.00) DOLLARS. Due to mitigating circumstances (first Class B medication violation in lengthy training career), FIFTEEN (15) days are to be served from April 4 through April 18, 2020 (inclusive). The remaining FIFTEEN (15) days are stayed on the condition that no Class A or Class B medication violation occurs in any racing jurisdiction within 365 days from the date of this ruling. FIDES RATIO (FR) is disqualified and all purse money forfeited. Pari-mutuel wagering is not affected by this ruling. During his suspension Mr. Turner is denied the privileges of all facilities under the jurisdiction of the Kentucky Horse Racing Commission. Entry of all horses owned or trained by Mr. Turner is denied pending transfer to persons acceptable to the stewards. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Kentucky Horse Racing Commission. Failure to do so will subject the licensee to summary suspension of license pursuant to 810 KAR 3:020 Section 15 (cc).
