Upon receipt of notification from Industrial Laboratories, the official testing laboratory for the Kentucky Horse Racing Commission, and confirmed at Texas A & M Veterinary Medical Diagnostic Laboratory, sample number E301424 taken from MOOLAH SCHMOOLAH, who finished second in the fifth race at Churchill Downs on November 4, 2018 contained Carisoprodol and metabolite Meprobamate in blood (Class B). Michael Dubb, et al waived their right to a formal hearing before the Board of Stewards. MOOLAH SCHMOOLAH is disqualified and all purse money forfeited. Pari-mutuel wagering is not affected by this ruling. All purse monies must be returned to the association. The purse of this race is ordered redistributed as follows:
