**STEWARDS RULING**

**Ruling number: 21-0002**

Upon receipt of notification from Industrial Laboratories, the official testing laboratory for the Kentucky Horse Racing Commission, and confirmed at Texas A & M Veterinary Medical Diagnostic Laboratory, sample number E378301 taken from SAFFA'S DAY, who finished first in the ninth race at Keeneland on October 11, 2020 contained dexamethasone at a level of 35.1 pg/ml in blood (Class C drug). Lee Levinson and Clark O. Brewster waived their right to a formal hearing before the Board of Stewards. SAFFA'S DAY is disqualified and all purse money forfeited. Pari-mutuel wagering is not affected by this ruling. All purse monies must be returned to the association. The purse of this race is ordered redistributed as follows:
