RE: PROPOSED CONDITIONS ON LICENSES TO CONDUCT LIVE HORSE RACING, SIMULCASTING, AND PARI-MUTUEL WAGERING

The Kentucky Horse Racing Commission (KHRC) is responsible for overseeing horse racing and wagering in Kentucky and has the authority to impose conditions on licensed associations pursuant to KRS 230.290(2). As a condition of licensure, the licensed associations must comply with various requirements related to regulatory notifications, operational reporting, racing integrity, and wagering integrity. The requirements include notifying the KHRC of any regulatory agency communication or investigation, sending copies of self-reporting documents to the KHRC, notifying the KHRC of any wagering anomalies, ensuring the totalizator and video provider are operating correctly, and reporting employee lists and vendor licenses.

The KHRC staff recommends approval of this condition and accompanying requirements on each association's license. If approved, the condition will be sent to all associations for compliance.

Kentucky Horse Racing Commission Condition of Licensure Pursuant to KRS 230.260

Pursuant to KRS 230.290(2), the Kentucky Horse Racing Commission ("KHRC") is authorized to prescribe necessary and reasonable conditions under which horse racing and wagering is conducted in the Commonwealth of Kentucky. Therefore, as a condition of licensure by the KHRC to conduct horse racing and wagering, each licensed association shall certify that it shall comply with the following requirements:

- 1. Regulatory Notifications
 - a. Each licensed association shall notify the KHRC of any communication, report, or investigation conducted or to be conducted by any federal, state, or local regulatory agency that relates to the safety, integrity, or security of the licensed association's operations, its participants, facilities, or that would reasonably be deemed to affect public confidence in the licensed association. This notification includes, but is not limited to, communications, reports, or investigations involving the Thoroughbred Racing Association ("TRA"), Thoroughbred Racing Protective Bureau ("TRPB"), United States Trotting Association ("USTA"), American Quarter Horse Association ("AQHA"), Arabian Jockey Club ("AJC"), National Thoroughbred Racing Association ("NTRA"), the Horseracing Integrity and Safety Authority ("HISA"), the Horseracing Integrity and Welfare Unit ("HIWU"), or any agency relating to environmental, safety or public health matters. Notification to the KHRC shall include or be supplemented by a copy of the communication, report, or investigation within twenty-four (24) hours of receipt by the licensed association.
 - b. Each licensed association shall notify the KHRC any time a member of a local, state, or federal law enforcement agency enters licensed association grounds for the purpose of questioning, investigating, or arresting a licensed individual. Such notice shall include or be supplemented by a copy of any report related to the questioning, investigation, or arrest prepared by the licensed association and/or prepared by the law enforcement agency. The report(s) shall be provided to the KHRC within twenty-four (24) hours of preparation and/or receipt by the licensed association.
- 2. Operational Reporting
 - a. Each licensed association shall send a copy of any self-reporting document, form, or correspondence to the KHRC at the same time that the document, form, or correspondence is filed with the state or federal regulatory agency, or any other organization referenced in Requirement No. 1. The licensed association shall identify to the KHRC any information contained in submitted reports that the licensed association considers to be proprietary.
 - b. Pursuant to 810 KAR 8:010 Section 20, purse money in thoroughbred, flat racing, and standardbred racing shall be paid, distributed, or made available no later than twenty-four (24) hours after notice from the Commission that a final laboratory report has been issued.
- 3. Racing Integrity Requirements

- a. Each licensed association shall record the date and time (in hours, minutes, and seconds) on all live video feeds originating from a Kentucky track. Each licensed association shall be responsible for recording (in hours, minutes, and seconds) the start/off time of each race. Further, each licensed association shall require the tote company with whom it does business to certify, and provide evidence of such certification, to the Chief State Steward or Presiding Judge of the closure time (in hours, minutes, and seconds) of the betting windows for each race. Records shall be retained for two years after the date of the race. Records shall be submitted to the KHRC upon request.
- b. Each of the timing systems mentioned in Requirement 3a. shall be synchronized with the U.S. Naval Observatory Clock at the beginning of each race day.
- c. Each licensed association offering thoroughbred racing shall require owners to deposit the fee for the administration of race-day furosemide, as permitted under Title 810 of the Kentucky Administrative Regulations, into the owner's account with the horsemen's bookkeeper by 12:00 p.m. Eastern on the day of the race. Failure of the owner to deposit such a fee may result in the owner being subjected to penalties, including fines or suspension. Each licensed association shall debit the owner's account for the Lasix fee to the credit of the KHRC.
- d. Each licensed association for thoroughbred racing shall abide by the safety and security requirements mandated by the Horseracing Integrity and Safety Act of 2020, as set forth in 15 U.S.C. 3051 *et seq.* ("HISA"). Each licensed association for any type of horse racing shall abide by all requirements set forth in KHRC statutes and regulations, to the extent that KHRC statutes and regulations are not preempted by HISA. All licensed associations shall be subject to inspection by KHRC officials and shall be required to make any repairs or improvements necessary to comply with the applicable safety and security regulations.
- 4. Wagering Integrity Requirements
 - a. Each licensed association shall notify the KHRC if it becomes aware of a wagering anomaly related to racing conducted at that licensed association or related to a race imported for simulcast wagering at the licensed association, even if a report has not been filed with any of the organizations referenced in Requirement No. 1. The licensed association shall provide transactional data and video of the race to the KHRC. Wagering anomalies are defined as any incident that might reasonably affect the public's confidence in the licensed association's wagering pools. Such incidents include, but are not limited to:
 - i. Past posting, cancel delay, and other instances when wagering occurs after the horses have left the gate;
 - ii. Off-shore and account wagering fraud;
 - iii. Suspected manipulation through computerized robotic wagering;
 - iv. Pool odds manipulation;
 - v. Quick pick or random pick malfunction;

- vi. Unusually large cancellation of wagers (especially right as the betting stops);
- vii. Outlets that are habitually late getting into the pools;
- viii. Manual merges;
- ix. Unusual payoffs;
- x. Failing to remove a scratched horse from the pools (which would then require a re-calculation of payoffs);
- xi. Re-entering a scratched horse to the pools without approval from the Stewards or Judges;
- xii. Suspicious wagering patterns;
- xiii. Totalizator or data communications malfunctions; and/or
- xiv. Substantial late ticket cancellations.

The list of wagering anomalies above is meant to be illustrative and not exclusive. It is the licensed association's responsibility to ensure that all wagering anomalies are communicated in a detailed and timely manner to the KHRC, whether by the licensed association or related vendor.

- b. Each licensed association shall ensure that the totalizator and video provider are available at least one week prior to the start of the live race meet for testing by the KHRC. Each licensed association shall ensure that the totalizator and video provider for its live meet are operating correctly at least 24 hours prior to the start of the live meet. Each licensed association shall ensure the video provider for its live meet performs its duties to the satisfaction of the KHRC, including, but not limited to, by having functional cameras and displaying all notifications timely and legibly for the wagering public.
- c. Each licensed association shall require its totalizator, video provider, and teletimer provider to share any and all racing and wagering data requested by the KHRC.
- d. Each licensed association shall post policies and procedures related to pari-mutuel wagering, including the licensed association's refund policy, on the licensed association's website. Each licensed association shall also post a notice in the racing program and a sign at the association's information window informing patrons where they can access a complete copy of the association's policies and procedures related to pari-mutuel wagering, including the association's refund policy.
- e. Each licensed association shall provide a copy of its mutuel department policies and procedures to the KHRC.
- f. Each licensed association shall have protocols in place that mandate exclusion of any receiving track's wagering pool when the licensed association cannot verify that all wagers in the receiving track's pool were received prior to the official start of the race. Copies of these protocols shall be provided to the KHRC.
- g. Each licensed association shall have protocols in place and shall publicize to its wagering patrons when, as a receiving track, it is excluded from a host track's wagering pool. These protocols shall include an immediate public announcement

and immediate posting on the licensed association's video monitors and websites. Copies of these protocols shall be provided to the KHRC.

- h. In the event of exotic wagering hosted by another jurisdiction on a licensed association's race date, whereby a KHRC official's actions pursuant to 810 KAR 2:040 Section 5(9) may impact the outcome of the wager, the licensed association must inform the KHRC of the following information at least three (3) calendar days prior to such wagering:
 - i. Type, number, and denomination of the wager;
 - ii. The specific performance (including, but not limited to, number, type of race, etc.) and racetrack involved in the wager; and
 - iii. Name and direct phone number for the person responsible for operating the wager for the host site and totalizator company.

Further, any such wager shall be included in the official race program of the licensed association. with the wager for each applicable race date.

- i. Each licensed association that does business with any individual, person, or entity that offers advance deposit account wagering ("ADW") to Kentucky residents shall ensure that the ADW is licensed by the KHRC prior to doing business with that ADW.
- j. Each licensed association shall submit an electronic copy of the Kentucky Department of Revenue Forms 73A100 and 73A101 to KHRC.Reports@ky.gov no later than 4:30 p.m. on the 5th business day (excluding Saturday and Sunday) following the close of each racing week. Note that each licensed association must report its wagers, including any wagers conducted through a subsidiary, on a single return for each period.
- k. Each licensed association shall settle (and pay, as required) all wagering accounts with simulcast partners on a timely basis, in no event exceeding 60 days past any respective due date.
- 1. Each licensee shall ensure sufficient printed copies of the program are made available to KHRC staff and shall provide a digital copy of the program to the KHRC via e-mail no later than six (6) hours prior to the first race of the program.
- m. All licensed associations are required to have a licensed tote employee on the premises during live racing.
- 5. Each licensed association shall submit to the KHRC a full employee list that includes the official title of the employee at the licensed association and the date of the employee's hire. This shall be submitted in a format approved by the Commission's Director of Licensing on a monthly basis, no later than the 5th business day of the month.
- 6. Each licensed association shall report to the KHRC in writing, as required by 810 KAR 3:020, Section 11, the discharge of any licensed employee within 24 hours of the event.
- 7. Each licensed association shall ensure that all vendors and vendor employees utilized for the licensed association's operations are properly licensed by the KHRC.

- 8. Each licensed association shall require that all vendors and vendor employees display a KHRC identification badge while on licensed association grounds.
- 9. All licensed associations must pay for allocated expenses of the Commission pursuant to invoice terms, as set forth in KRS 230.240(3).

All notices required to be given to the KHRC under this condition of licensure, unless otherwise stated, shall be provided to the Executive Director, Deputy Executive Director, Chief State Steward/Presiding Judge, and Director of Pari-Mutuel Wagering and Compliance via hand delivery and/or electronic mail triggering the notice requirement. In the event a licensed association does not comply with the requirements, the KHRC has the authority to assess fines and/or penalties, including, but not limited to, licensure revocation. Additional conditions may be added to an association's license at any time at the discretion of the KHRC.

In its application for a license to conduct live horse racing, simulcasting and pari-mutuel wagering, Turfway Park, LLC ("Turfway Park") sought and received an award of 2023 race dates, including March 3, 2023. Due to deteriorating weather conditions, Turfway Park canceled racing on March 3, 2023. On March 4, 2023, General Manager Chip Bach requested approval to conduct the originally scheduled race date on March 15, 2023.

On March 23, 2023, Turfway Park requested the addition of two Super High 5 pari-mutuel pools for *Jeff Ruby Steaks* and *Bourbonette Oaks* stakes races. The KHRC staff determined that the pools requested complied with 810 KAR 6:020.

Due to the time constraints of both requests, Executive Director Jamie Eads granted conditional approvals for Turfway Park to conduct racing on the alternate date and offer the aforementioned pari-mutuel pools. KHRC staff recommends ratification of Executive Director Eads' approvals.

The KHRC Rules Committee and KHRC Chief Steward Barbara Borden recommend amending 810 KAR 4:090.

The primary proposed changes are summarized as follows:

- Removes language from the Joint Ownership section limiting the number of individual persons that can be licensed as owners of a single horse.
- Amends language under the Joint Ownership section such that if more than two (2) individuals own an interest in a single horse, then those individuals shall designate one of the individual owners to represent the entire ownership group and be responsible for the horse as the licensed principal owner.
- Amends language under the Program Listing of Owners section to allow for up to ten (10) individual owners or entities to be listed in the program as owners of a single horse. Stable names, partnerships, corporations, syndicates, or other joint ventures may be listed in the program with the principal owner's name shown parenthetically.
- Adds language to the Leases section to clarify that a lease shall not be approved by the stewards for racing purposes unless the lessee is licensed as an owner or is eligible to obtain an owner's license.
- Amends language under the Partnerships section such that partnership papers shall be filed with an owner's license application if requested by the stewards or the commission.

The KHRC Rules Committee voted in favor of recommending approval of these amendments on April 11, 2023. The KHRC staff also recommends approval.

This administrative regulation establishes the rules concerning horses in thoroughbred and other flat racing.

The emergency amendment allows Quarter Horses to compete wearing horse shoes with toe grabs. For Quarter Horses only, front horse shoes may have a toe grab measuring up to 4 mm from the ground surface side of the shoe. For Quarter Horses only, back horse shoes may have a toe grab measuring up to 0.25 inches from the ground surface side of the shoe.

This administrative regulation was approved on an emergency basis, as the need of Quarter Horse regulations allowing toe grabs was discovered only days before the April 2023 Revolutionary Racing Quarter Horse meet at the Red Mile.

KHRC staff are working together with the Quarter Horse stewards to develop ordinary regulations addressing this matter and other important issues that are unique to Quarter Horse Racing. That ordinary regulation should come before the Commission at its regular June 2023 meeting.

The KHRC staff recommends ratification of the Executive Director's approval of this emergency regulation.

STATEMENT OF EMERGENCY

810 KAR 4:010E

This emergency regulatory amendment is promulgated to meet an imminent threat to public health, safety, or welfare, and to prevent a loss of state funds. On March 27, 2023, the Commission was alerted to a safety concern associated with requiring Quarter Horses to race with flat shoes, as currently required for all other horses participating in flat racing in Kentucky. This administrative regulation will align Kentucky with the standards set in prominent Quarter Horse racing jurisdictions. This regulation amendment is filed on an emergency basis to allow Quarter Horses at the April 2023 meet to wear toe grab shoes in order to ensure public health, safety, and welfare.

This emergency regulation will not be replaced by an ordinary administrative regulation at this time. Instead, an ordinary administrative regulation will be filed at a later date, and will contain additional Quarter Horse conditions that are not emergent in nature. The ordinary administrative regulation will not be identical to this emergency administrative regulation.

(d) How this administrative regulation currently assists or will assist in the effective administration of the statutes: This administrative regulation sets forth requirements and rules concerning the health and safety of horses in thoroughbred and other flat racing that enhance the integrity of racing.

(2) If this is an amendment to an existing administrative regulation, provide a brief summary of:

(a) How the amendment will change this existing administrative regulation: This amendment will allow Quarter Horses to wear toe grab horses shoes, while participating in the April 2023 Sandy Ridge meet at the Red Mile.

(b) The necessity of the amendment to this administrative regulation: This amendment is necessary to preserve the health and safety of the human and equine athletes participating in the April 2023 Sandy Ridge meet at the Red Mile, by providing the horses with sufficient traction to safely exit the starting gate.

(c) How the amendment conforms to the content of the authorizing statutes: KRS 230.215(2) and 230.260(8) authorize the commission to promulgate administrative regulations

regulating horse racing in Kentucky and this amendment involves when a horse may be entered or raced in Kentucky.

(a) List the actions that each of the regulated entities identified in question (3) will have to take to comply with this administrative regulation or amendment: Participants in horse racing, and especially owners, trainers, veterinarians, and jockeys, will be required to adhere to the requirements and rules set forth in this administrative regulation pertaining to the health and safety of horses in thoroughbred and other flat racing. In particular, Quarter Horse owners and trainers may voluntarily choose to allow their horses to compete with toe grab horse shoes.

Pursuant to KRS Chapter 230.260(15), the KHRC is required to promulgate regulations establishing a self-exclusion list.

Please find attached a proposed regulation that establishes a self-exclusion list for individuals who self-identify as being problem or compulsive gamblers. If approved, each track will be required to display a notice to the public of patrons' right to add themselves to the self-exclusion list, as well as the method or methods individuals may use to self-identify at the track, online, or by phone.

Furthermore, self-exclusion information collected by each racing association shall be forwarded to the racing commission, and the information from the racing associations shall be compiled into a comprehensive list that shall be provided to all racing associations.

It is important to note that pursuant to KRS 61.878(1)(a), information collected under this subsection shall be excluded from the application of Kentucky's Open Records Act, set forth in KRS 61.870 to 61.884.

PUBLIC PROTECTION CABINET Kentucky Horse Racing Commission (New Regulation) 810 KAR 2:100 Self-Exclusion RELATES TO: STATUTORY AUTHORITY: NECESSITY, FUNCTION AND CONFORMITY: Section 1: Self-Exclusion List.

(1) The racing commission shall establish and maintain a self-exclusion list for individuals who self-identify as problem or compulsive gamblers.

(2) The list shall include the names and other identifying information of the individuals who have self-excluded from gambling at racing tracks, as set forth in Section 3(1).

Section 2: Notice to the Public.

(1) Each racing association shall display a notice to the public of the existence of the self-exclusion list and the method or methods individuals may use to self-identify at the track, online, or by phone.

(2) The notice shall be displayed at public entrances to the wagering-specific locations of the racing track and on the racing association's website.

(3) The notice shall include information about the consequences of self-exclusion, including that the individual will be prohibited from entering the racing track and participating in any gambling activity at the track.

(4) The notice and its placement locations shall be approved by the commission.

Section 3: Collection of Self-Exclusion Information.

(1) Each racing association shall collect self-exclusion information from individuals who selfidentify as problem or compulsive gamblers. (2) The self-exclusion information collected shall include the individual's name, address, date of birth, and other identifying information as prescribed by the racing commission.

(3) The racing association shall provide the self-exclusion information to the racing commission on a weekly basis and in a manner approved by the commission.

Section 4: Compilation of Comprehensive List.

(1) The racing commission shall compile and maintain a comprehensive list of all individuals who have self-excluded from gambling at racing tracks.

(2) The comprehensive list shall include the self-exclusion information provided by each racing association.

(3) The comprehensive list shall be provided to all racing associations and updated on an asneeded basis.

Section 5: Confidentiality of Self-Exclusion Information.

Section 6: Self-exclusion policy.

(1) Each racing association may establish its own self-exclusion policy. Each policy shall be approved by the racing commission to ensure the best interests of horse racing and compliance with KRS 230.260.

(2) The policy may cover how the racing association chooses to exclude individuals on the exclusion list. The policy may include identification and verification, forfeiture of prizes by excluded

The KYQHPAA Development Fund Advisory Committee met on March 28, 2023 to approve the proposed changes to 810 KAR 7:060 and its incorporated documents to include the following:

- General maintenance of the regulation to be in compliance with our current regulations and statutes.
- To promote Kentucky-bred horses and to increase the horse population within the state, a Kentucky Bred mare is no longer required to remain in the state of Kentucky "continuously." Instead, she will only need to remain in the state of Kentucky from conception until foaling for a period totaling no less than 120 days.
- The mare nomination deadline will be extended to December 31st for both breeding years of 2023 and 2024.
- There will be no nomination fees for a Kentucky-bred mare to nominate to the fund for both breeding years of 2023 and 2024.
- Allow for horses born before 2024 to nominate to the fund, as long as the owner can prove the horse's mare conceived in Kentucky, resided in Kentucky no less than 120 days during gestation, and foaled in Kentucky.

All changes to the regulation are included in the "track changes" version of the regulation, as well as the new incorporated forms, which are attached to this memorandum.

The KYQHPAA Advisory Panel recommends approval along with the KHRC staff at this time.

RE: 810 KAR 7:030 KENTUCKY THOROUGHBRED DEVELOPMENT FUND REGULATION CHANGE REQUEST

The KTDF Advisory Committee met on April 5, 2023 and voted on proposed changes to 810 KAR 7:030. The primary suggested amendments are as follows:

- General maintenance of the regulation to comply with our current regulations and statutes. This includes removing obsolete definitions and adding certain helpful definitions, such as defining a "licensed association."
- Removal of obsolete language or duplication of language in other regulations and statutes. This includes ensuring that the regulation is consistent with its enabling statute, KRS 230.400.
- In Section 3, amending the regulation such that a surplus of KTDF money generated from live, simulcast and HHR pari-mutuel wagering can be treated the same way by the licensed association.
- In Section 3 (5), adding clarification language regarding advertising with KTDF Funds.

All changes to the regulation are included in an LRC-compliant version of the regulation, which is attached to this memorandum.

Ellis Park has reviewed our purses and would like to card KTDF purses in the range of \$3.7 million to \$4.4 million for our upcoming Summer Meet. We have based the range on the following information:

- 1. At the end of the 2022 meet, there was a KTDF deficit of \$295,772 of which the balance at the end of November 2022 was a KTDF surplus balance of \$8,322.
- 2. Since the end of November 2022, we have generated and expect to generate KTDF from the following sources through the end of August 2023:
 - a. Transfer of \$1.75 million in KTDF funds from Kentucky Downs
 - b. Transfer of \$1.1 million in KTDF funds from Oak Grove
 - c. Ellis Park historical racing machine contribution of \$1.3 million
- 3. Our summer will consist of 24 racing days beginning July 7, 2023 and ending Sunday August 27, 2023.
- 4. We anticipate that KTDF will be approximately 23% of total purses. Of the requested KTDF allotment, we anticipate the following payouts:
 - a. ALW, AOC, MSW: approximately 60% of the KTDF allotment
 - b. BCL, CLM, MCL, STR, WMC: approximately 15% of the KTDF allotment
 - c. Stakes: approximately 25% of the KTDF allotment
- 5. For summer meet 2023, we are assuming a KTDF payout percentage of 95% with anticipated KTDF disbursements of \$4.1 which is consistent with the \$4.2 million paid during the summer 2023 summer meet.
- 6. To encourage participation during the summer meet, we are again planning to pay KTDF purses from first to last to all eligible horses.

During calendar year 2022, Horsemen with Kentucky-sired Kentucky-breds have over \$48 million more in purse money to run for in designated stakes, handicap, allowance, non-claiming maiden races, and claiming races contested at licensed Thoroughbred race meetings in Kentucky.

Eligible races can be readily recognized in the stakes and condition books by the Kentucky Thoroughbred Development Fund seal, which will appear next to each race in the stakes and condition books.

I am writing to update you on some prospective improvements to the upcoming Ellis Park meeting. As you know, Churchill Downs Incorporated has acquired Ellis Park and this will be the first meeting under CDI's operation. Here are some exciting developments for Ellis Park:

- Ellis will be making best efforts to run a minimum of 9 races per day, and increase over last year's 8 races per day schedule
- The American Graded Stakes Committee recently approved the relocation of the Grade 3 Pucker Up Stakes to Ellis Park. This will be a \$300,000 race that gives Ellis a prominent graded race to center the meet around.
- Ellis Park will be working to improve the digital broadcast production of Ellis Park's races and will utilize the Churchill Downs experts for on air commentary at Ellis Park.
- Ellis Park has hired Erin McElwee to be the Director of Racing Operations at Ellis. Erin comes from her previous role as Director of Facilities for Laurel / Pimlico and her experience working on the backside before transitioning to the front side will make her very valuable to Ellis Park.
- Ellis has been working diligently to make a number of facility wide improvements that will greatly enhance the safety and experience of guests. Most notably, Ellis Park will feature a brand new video screen in the infield for on track fans to better view the live races, as well as significantly increasing parking lot lighting and replacing the main entrance canopy.
- Finally, as is the case with other CDI owned properties, Ellis will be prominently featured on Twinspires.com for fans across the country to wager.

On April 5, 2023 the KTDF Advisory Committee considered the following request from Kentucky Downs regarding its KTDF purse structure for their upcoming 2023 race meet. Their meet will consist of 7 racing days beginning on Thursday, August 31st and ending on Wednesday September 13th.

Kentucky Downs is proposing KTDF purses in the range of 10.1 - 11.1 million. These projections are based on a projected KTDF earned balance of 14.1 million at the end of March 2023 with the primary driver attributed to pari-mutuel wagering on historical horse racing at Kentucky Downs and Bowling Green.

To encourage participation during the meet, Kentucky Downs will pay out KTDF purses through last place to all KTDF eligible horses.

The Advisory Committee also approved a request from Kentucky Downs to advertise KTDF purses pursuant to 810 KAR 7:030. The proposal that was considered and approved is almost identical to what they did last year.

The KTDF Advisory Committee along with KHRC staff recommend approval at this time.

Kentucky Downs has reviewed our purses and would like to offer KTDF purses in the range of \$10.1 million to \$11.1 million for the upcoming September meet. We have based the range on the following information.

- 1. At the end of March 2023, Kentucky Downs is projecting an ending KTDF earned balance of \$14,146,773.
- Our 2023 September meet will consist of 7 racing days, beginning on August 31st and ending on September 13th. We are projecting additional earnings of \$8,389,805 by the end of September. The primary driver is the KTDF portion of the HHR revenue from The Mint Gaming Hall at Kentucky Downs and Bowling Green.
- We anticipate that KTDF will be approximately 45% of total purses. Of the requested KTDF allotment, we anticipate the following payouts:
 - a. ALW, AOC, MSW: approximately 36% of the KTDF allotment
 - b. CLM: approximately 1% of the KTDF allotment
 - c. Stakes: approximately 63% of the KTDF allotment
- 4. For September 2023, we are assuming a KTDF payout percentage of approximately 90% with anticipated KTDF disbursements of approximately \$10,200,000 which is an increase of \$3,600,000, or 54% higher than 2022.
- 5. To encourage participation during the September meet, we are again planning to pay KTDF purses from first to last to all eligible horses.

On March 16, 2023, KHRC received the following request for a Backside Improvement Fund expenditure from Churchill Downs. Churchill Downs barn roofs were in need of immediate repair due to the windstorms that impacted Kentucky in early March. Horses were scheduled to arrive on property in March and there was an immediate need to repair the barns without delaying the arrival of horses. Therefore, this request was approved by Executive Director Jamie Eads.

KHRC staff confirms the projects meet the statutory requirements of KRS 230.3615 and 810 KAR 7:010 and the funding is available. KHRC staff will inspect the areas again once the projects are complete. All invoices, photographs and communication will remain on file for Commission review. The KHBPA and KTA-KTOB approve this request.

The KHRC staff recommends ratification of Executive Director Jamie Eads' approval of expenditures of Backside Improvement Funds to repair barn roof damage at Churchill Downs.

- 1. Nature of Work. Commonwealth Roofing Corp. (CRC) shall furnish the labor and material to perform the work described in this proposal. While CRC suggests solutions, it is not a licensed design firm and does not provide design, engineering, consulting or architectural services. It is the Customer's responsibility to retain a licensed architect, consultant, or engineer if required to determine proper design and code compliance. CRC assumes no responsibility for structural integrity, compliance with building, UL, FM or other codes, or other design criteria. If plans or specifications have been furnished to CRC, Customer warrants that they are sufficient and conform to applicable codes. CRC is not responsible for damage or expense due to defects in plans or specifications or building code violations unless such damage results from a deviation by CRC from the contract documents. Customer warrants all structures to be in sound condition capable of withstanding activities of roof equipment, personnel, and operations. CRC is not responsible for location of roof drains, adequacy of drainage or ponding on the roof. Clerical, grammatical, and typographical errors and omissions subject to correction consistent with the intent of this proposal.
- 2. Asbestos and Toxic Materials. Unless stated otherwise on the face of this proposal, this contract is based on the assumption that the work to be performed by CRC does not involve asbestos-containing or toxic materials and that such materials will not be encountered or disturbed during the course of performing the roofing work. CRC is not responsible for expenses, claims or damages arising out of the presence, disturbance or removal of asbestos-containing or toxic material. In the event that we become aware that such materials are encountered, CRC will stop work in the affected area and submit a change order to perform the necessary work for additional compensation. CRC shall be entitled to reasonable compensation for additional expenses incurred as a result of the presence of asbestos-containing or toxic materials.
- 3. Insurance. CRC shall carry worker's compensation, automobile liability and commercial general liability insurance and will furnish a Certificate of Insurance upon request. Customer shall maintain builder's risk and property insurance upon the full value of the Project, including the labor, material and equipment furnished by CRC, covering fire, wind, extended coverage, vandalism and theft to protect against loss or damage to material and equipment and partially completed work until the job is completed and accepted and CRC's equipment is removed.
- 4. Payment. Unless stated otherwise on the face of this proposal, Customer shall pay the contract price plus any additional charges for changed or extra work upon completion of the Work. If completion of the Work extends beyond one month, Customer shall make monthly progress payments by the fifth (5th) day of each month for the value of Work completed during the preceding month. All sums not paid in full when due shall earn interest at the rate of 1-1/2% per month. - 5. Tolerances. All materials and work shall be furnished in accordance with normal industry tolerances for color, variation, thickness, size, weight, amount, finish, texture, and performance standards. CRC is not responsible for the actual verification of technical specifications of product manufacturers; e.g. R-value or ASTM or UL compliance, but rather the materials used are represented as such by the material manufacturer. Specified quantities are approximate and intended to represent an approximation or an average over the entire roof area.
- 6. Working Hours. This Proposal is based upon commencement of the work within 180 days from contract signing and performance of all work during CRC's regular working hours. Extra charges will be made for overtime and all work performed other than during CRC's regular working hours if required by Customer.
- 7. Availability of Site. CRC shall be provided with direct access to the work site for the passage of trucks and materials and direct access to the roof. CRC shall not be required to begin work until underlying areas are ready to receive CRC's work and sufficient areas of roof deck and building are available and free from hazards, dirt, snow or debris to allow safe, continuous, full operation until job completion. The expense of any extra trips to the job as a result of the job not being ready for roof application after CRC has been notified to proceed will be charged as an extra. For time-and-materials extra work and service work, time is figured portal to portal.
- 8. Changes in the Work and Extra Work. Customer shall be entitled to order changes in the Work and the total contract price adjusted accordingly. Any penetrations through the roofing not shown on the plans provided to CRC prior to submittal of this proposal shall be considered an order for extra work, and CRC shall be compensated for costs incurred by CRC resulting from such additional penetrations. If unknown or concealed conditions requiring additional work are discovered during the course of performing the work, CRC shall bring these conditions to the Owner's attention and such additional work as may be required shall be performed as an extra on a time-and-materials basis. CRC reserves the right to revise this contract in the event of a sudden and inordinate increase in the cost of furnished materials.
- 9. Warranty. CRC's workmanship is guaranteed by CRC against leakage for the period of time specified on the face of this proposal. In the event that a warranted leak occurs at the place of CRC's work within this warranty period, the Customer shall notify CRC immediately and CRC will repair the leak at no cost to the Customer. CRC SHALL NOT BE LIABLE FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES including, but not limited to, loss of profits, mold, or damages to the building or its contents.
