STEWARDS RULING

Owner/Trainer: Michael Ann Ewing (D.O.B. 5/20/1954)

Upon receipt of notification from LGC Science, Inc., the official testing laboratory for the Kentucky Horse Racing Commission, and confirmed at Industrial Laboratories (Industrial Sample Lab ID Number: S-16-08), sample number 0086010 taken from COVERT GEM, who finished first in the sixth race at Churchill Downs on November 28, 2015 contained dextrophan in urine (Class B drug). After a formal hearing before the Board of Stewards you are hereby suspended THIRTY (30) days, September 1, 2016 through September 30, 2016 (inclusive) and fined FIVE HUNDRED (\$500.00) DOLLARS. COVERT GEM is disqualified and all purse money forfeited. Pari-mutuel wagering is not affected by this ruling. During her suspension Ms. Ewing is denied the privileges of all facilities under the jurisdiction of the Kentucky Horse Racing Commission. Entry of all horses owned or trained by Ms. Ewing is denied pending transfer to persons acceptable to the stewards. Upon receipt of this ruling, you are required within thirty (30) days to pay any and all fines imposed to the Kentucky Horse Racing Commission. Failure to do so will subject you to summary suspension of your license pursuant to 810 KAR 1:025 Section 14 (cc).
