## STEWARDS RULING

**Ruling number: 16-0078**  
**LGC Sample #0087653**

**Track: Kentucky Downs**

**Owner/Trainer: Anita Dawn Roe (D.O.B. 6/27/1968)**

Upon receipt of notification from LGC Science, Inc., the official testing laboratory for the Kentucky Horse Racing Commission, sample number 0087653 taken from THIRTY EIGHT PLUS, who finished fourth in the first race at Ellis Park on July 16, 2016 contained MULTIPLE NSAIDS; phenylbutazone (1.3 ug/ml in blood) and flunixin (4.3 ng/ml in blood). The concentrations of both permitted NSAIDS are below the primary threshold and above the secondary threshold. After waiving your right to a formal hearing before the Board of Stewards you are hereby suspended FIVE (5) days, September 19, 2016 through September 23, 2016 (inclusive) and fined TWO HUNDRED FIFTY (\$250.00) DOLLARS. Purse monies and pari-mutuel wagering are not affected by this ruling. During her suspension Ms. Roe is denied the privileges of all facilities under the jurisdiction of the Kentucky Horse Racing Commission. Entry of all horses owned or trained by Ms. Roe is denied pending transfer to persons acceptable to the stewards. Upon receipt of this ruling, you are required within thirty (30) days to pay any and all fines imposed to the Kentucky Horse Racing Commission. Failure to do so will subject you to summary suspension of your license pursuant to 810 KAR 1:025 Section 14 (cc).
