**STEWARDS RULING**

**Ruling number: 20-0071**

**Track: Keeneland**

**Owner/Trainer: Madelyn A. Royal (D.O.B. 10/27/1956)**

**Pursuant to the Settlement Agreement and Stipulation in the case of Edward Bray and Madelyn Royal vs. KHRC (Administrative Action #KHRC-19-TB-008 & 015), Owner/Trainer Madelyn A. Royal is hereby suspended NINETY (90) days, October 21, 2020 through January 18, 2021 (inclusive) and fined FIVE HUNDRED (\$500.00) DOLLARS. MISS PINKERTON (Turfway Park February 14, 2019), is disqualified and all purse money forfeited. Pari-mutuel wagering is not affected by this ruling. During her suspension Ms. Royal is denied the privileges of all facilities under the jurisdiction of the Kentucky Horse Racing Commission. Entry of all horses owned or trained by Ms. Royal is denied pending transfer to persons acceptable to the stewards. At the conclusion of the suspension, Ms. Royal shall remain suspended and ineligible to obtain a license until all conditions of the Settlement Agreement and Stipulation have been satisfied, including payment of fine and return of purse money to Turfway Park.**
