TEST: 1<sup>st</sup> 1 & 10 (C 3-voided, 11-voided & 12), 2<sup>nd</sup> 2 & 6, 3<sup>rd</sup> 4 & 5 (C 6 & 12-voided), 4<sup>th</sup> 3 & 10, 5<sup>th</sup> 2 & 9, 6<sup>th</sup> 1 & 2, 7<sup>th</sup> 8, 11 & 12, 8<sup>th</sup> 3 & 4, 9<sup>th</sup> 5, 7, 9 & 10, 10<sup>th</sup> 2, 3 & 8, 11<sup>th</sup> 5 & 10.

1<sup>st</sup> RACE Camile Hargrove rode #10 "Stuck On You", her first probationary mount. #10 "Stuck On You" (Camile Hargrove) finished seventh, BLED, and was placed on the See State Vet list. The claims of both #3 "Missile" and #11 "Let's Go Brandi" were voided pursuant to HISA Rule #2262 when the horses were placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3<sup>rd</sup> RACE The claim of #12 "Summonyourcourage" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

4<sup>th</sup> RACE A Stewards Inquiry was posted into the stretch run and, in addition, an objection was lodged by the rider of third place #3 "Lou's Legacy" (Albin Jimenez) alleging interference by the rider of #4 "Fracture" (Walter Rodriguez) in the stretch. After reviewing the race replay and interviewing the riders of #3, #4 and fifth place #9 "Shadow Surge" (Irad Ortiz, Jr.) the stewards determined that #4 bore in sharply several times in the stretch, impeding both #3 and #9. For the interference #4 was disqualified from second and placed fifth, behind #9. Official order of finish: 10-3-5-9
