


5<sup>th</sup> RACE #8 "Codetowin" who was claimed by Maggi Moss was pulled up abruptly near the 5/16 pole and required the assistance of the KHRC veterinarians and the horse ambulance. It was determined that the horse could be transported to the test barn to be observed while cooling out. Ultimately, the claim of #8 "Codetowin" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
