After reviewing the race replay and interviewing the riders the stewards determined that #6 always maintained a straight course, and that instead, the inside horse, third place #10 "Carmelo" (Emmanuel Esquivel) drifted out slightly. There was no change in the order of finish and the race was posted official.
