A Stewards Inquiry was posted when #2 "Magic Star" (David Cohen) fell and unseated her rider going into the first turn. After reviewing the race replay the stewards determined that the horse reacted when in tight quarters, and that she had not been interferred with by a rival. There was no change in the order of finish and the race was posted official. A conversation with Cohen after the ordeal confirmed the stewards' findings. The rider was not seriously injured and the filly left the track on her own power and was attended to by the private veterinarian.
