RE: PROPOSED AMENDMENTS TO 810 KAR 4:070. JOCKEYS AND APPRENTICES

The Kentucky Thoroughbred Association/Kentucky Thoroughbred Owners and Breeders Association ("KTA/KTOB"), as well as the Kentucky Horsemen's Benevolent and Protective Association ("KHBPA") and the Jockeys' Guild have agreed to certain changes to modernize the jockey fees set forth in 810 KAR 4:070. The following is a summary of the proposed regulatory changes to Section 8. Jockey Fees in Thoroughbred Racing:

- The original structure of providing different fees for several different purse ranges below \$99,999 is removed.
- All purses up to \$99,999 will have the same fee structure. That fee structure is as follows:
 - 10% for the winning mount;
 - o Greater than 5% or \$140, whichever is greater for the second place mount;
 - Greater than 5% or \$135, whichever is greater for the third place mount;
 - o Greater than 5% or \$130, whichever is greater for the fourth place mount; and
 - \$125 for the losing mount.
- The fee structure for purses between \$100,000 and \$999,999 is as follows:
 - 10% for the winning mount;
 - o 5% for the second, third, and fourth place mounts; and
 - \$125 for the losing mount.
- The fee structure for purses that are \$1 million and up is as follows:
 - o 10% for the winning mount;
 - o 5% for the second, third, and fourth place mounts; and
 - \$500 for the losing mount.

The Rules Committee recommends that the Commission approve these proposed amendments. The KHRC staff also recommends approval.

810 KAR 4:070. Jockeys and Apprentices.

RELATES TO: KRS 230.215, 230.260

STATUTORY AUTHORITY: KRS 230.215(2), 230.260(8), 230.260 (10), 230.260 (14)

NECESSITY, FUNCTION, AND CONFORMITY: KRS 230.215(2) and KRS 230.260(8)

authorize the Kentucky Horse Racing Commission to promulgate administrative

regulations prescribing conditions under which all horse racing is conducted. KRS

230.260(10) authorizes the commission to promulgate administrative regulations

establishing minimum fees for jockeys in the absence of a contract between an employing

owner or trainer and a jockey. KRS 230.260(14) authorizes the commission to promulgate

administrative regulations to establish safety standards and minimum fees for jockeys.

This administrative regulation establishes the requirements for jockeys and apprentice

jockeys.

Section 1. Probationary Mounts. Any person desiring to participate in this state as a

jockey, who has not ridden in a race previously, may ride in three (3) races before applying

for a license as a jockey or apprentice jockey if:

(1) The person is a licensed stable employee, assistant trainer, or trainer with at least

one (1) year of service with a racing stable;

(2) A licensed trainer certifies in writing to the stewards that the person has

demonstrated sufficient horsemanship, as evidenced by control of the animal while

mounting, riding, and dismounting in race and nonrace conditions, to be permitted the

probationary mounts;

- (3) The starter has schooled the person in breaking from the starting gate with other horses and approves the person as capable of starting a horse properly from the starting gate in a race;
- (4) The stewards determine that the person:
 - (a) Intends to become a licensed jockey;
 - (b) Possesses the physical ability to be a jockey; and
 - (c) Has demonstrated the ability to ride in a race without jeopardizing the safety of horses or other jockeys in the race; and
- (5) The person has prior oral or written approval of the stewards.
- Section 2. Qualifications for License. In addition to the requirements applicable to licensees under 810 KAR 3:020, a holder of a license as a jockey or apprentice jockey:
 - (1) Shall be sixteen (16) years of age or older and licensed under his or her legal name, which shall be listed in the daily race program;
 - (2) Shall have served at least one (1) year with a racing stable;
 - (3) Shall have ridden in at least three (3) races; and
 - (4) Shall, if required by the stewards, to protect the health and safety of the jockey, other jockeys, the horses, or the welfare of the betting public, provide a medical affidavit certifying the person is physically and mentally capable of performing the activities and duties of a licensed jockey.

Section 3. Amateur or Provisional Jockey.

(1) An amateur wishing to ride in races on even terms with professional riders, but without accepting fees or gratuities, shall:

- (a) Be approved by the stewards as to competency of horsemanship, as demonstrated by meeting the requirements in Section 1(2), (3), and (4)(b) and (c) of this administrative regulation;
- (b) Be granted an amateur jockey's license; and
- (c) Have amateur status duly noted on the daily race program.
- (2) A licensed owner or licensed trainer, upon approval by the stewards, may be issued a provisional jockey's license to ride his or her own horse or horse registered in his care as trainer.

Section 4. Apprentice Allowance in Thoroughbred Racing.

- (1) The provisions of this section apply only to thoroughbred racing.
- (2) Any person sixteen (16) years of age or older, who has not been licensed previously as a jockey in any jurisdiction, and who is qualified under Section 2 of this administrative regulation, may claim in all purse races except handicaps the following weight allowances:
 - (a) Ten (10) pounds until he or she has ridden five (5) winners;
 - (b) Seven (7) pounds until he or she has ridden an additional thirty-five (35) winners;
 - (c) If he or she has ridden a total of forty (40) winners prior to the end of one (1) year from the date of riding his fifth winner, he or she shall have an allowance of five (5) pounds until the end of that year; and
 - (d) If after one (1) year from the date of the fifth winner, the apprentice jockey has not ridden forty (40) winners, the applicable weight allowance shall continue for one (1) additional year, or until the 40th winning mount, whichever occurs first.

(3)

- (a) After the completion of conditions in subsection (1) of this section, a contracted apprentice may claim three (3) pounds for one (1) year if riding horses owned or trained by his or her original contract employer if his or her contract has not been transferred or sold since his or her first winner.
- (b) The original contract employer shall be the party to the contract who was the employer at the time of the apprentice jockey's first winner.
- (c) Apprentice allowance shall not be claimed for a period in excess of two (2) years from the date of the rider's fifth winner unless an extension has been granted in accordance with subsection (4) of this section.
- (4) An apprentice jockey may enter into a contract with a licensed owner or licensed trainer qualified under Section 5 of this administrative regulation for a period not to exceed five (5) years.
 - (a) These contracts shall be:
 - Approved by the stewards;
 - 2. Filed with the commission; and
 - 3. Binding in all respects on the parties to the contract.
 - (b) An apprentice who has not entered into a contract pursuant to this subsection shall be given an apprentice jockey certificate.
- (5) If an apprentice jockey is unable to ride for a period of seven (7) consecutive days or more because of service in the armed forces of the United States, physical disablement, attendance in an institution of secondary or higher education, restrictions on racing, or other valid reason, the commission, upon recommendation of the stewards and after consultation with the racing entity that approved the original apprentice

contract, may extend the time during which the apprentice weight allowance may be claimed for a period no longer than the period the apprentice rider was unable to ride.

(6) After completion of conditions in subsection (1) of this section, the rider shall be issued a license as a jockey before accepting subsequent mounts. Under these circumstances, the commission may waive collection of an additional license fee.

Section 5. Rider Contracts.

- (1) All riding contracts for terms longer than thirty (30) days, and any amendments, cancellation, or transfer of the contract, shall be in writing with the signatures of the parties notarized, and shall be approved by the stewards and filed with the commission.
- (2) The stewards shall approve a riding contract and permit parties to participate in racing in this state if the stewards determine that:
 - (a) The contract employer is a licensed owner or licensed trainer who owns or trains at least three (3) horses eligible to race when the contract is executed;
 - (b) The contract employer possesses the character, ability, facilities, and financial responsibility conducive to developing a competent race rider; and
- (c) If it is a contract for an apprentice jockey, the contract provides for fair remuneration, adequate medical care, and an option equally available to both employer and apprentice jockey to cancel the contract after two (2) years from the date of execution.

Section 6. Restrictions as to Contract Riders. A contract rider shall not:

- (1) Ride any horse not owned or trained by his contract employer in a race against a horse owned or trained by his or her contract employer;
- (2) Ride or agree to ride any horse in a race without consent of his or her contract employer;

- (3) Share any money earned from riding with his or her contract employer; or
- (4) Accept any present, money, or reward of any kind in connection with his or her riding of any race except through his or her contract employer.

Section 7. Calls and Engagements.

- (1) Any rider not prohibited by contract may agree to give first or second call on his or her race-riding services to any licensed owner or trainer.
- (2) Any rider employed by a racing stable on a regular salaried basis shall not ride against the stable that employs him or her.

Section 8. Jockey Fees in Thoroughbred Racing.

(1) The fee to a jockey, in the absence of special agreement to the contrary, shall be as follows:

(b) The flat fee amounts as established in paragraph (a) of this subsection are not percentage driven.

- (2) A jockey fee shall be considered earned by a rider if he or she is weighed out by the clerk of scales, with the following exceptions:
 - (a) If a rider does not weigh out and ride in a race for which he or she has been engaged because an owner or trainer engaged more than one (1) rider for the same race, the owner or trainer shall pay an appropriate fee to each rider engaged for the race;
 - (b) If a rider capable of riding elects to take himself off the mount without, in the opinion of the stewards, reasonable cause; or
 - (c) If a rider is replaced by the stewards with a substitute rider for a reason other than a physical injury suffered by the rider during the time between weighing out and start of the race.

Section 9. Jockey Fees for Quarter Horse, Paint Horse, Appaloosa, and Arabian Racing.

(1) The fee to a jockey in all races shall be, in the absence of special agreement, as follows:

- (2) A jockey fee shall be considered earned by a rider when he or she is weighed out by the clerk of scales, with the following exceptions:
- (a) If a rider does not weigh out and ride in a race for which he or she has been engaged because an owner or trainer engaged more than one (1) rider for the same race, the owner or trainer shall pay an appropriate fee to each rider engaged for such race;
- (b) If a such rider capable of riding elects to take himself or herself off the mount without, in the opinion of the stewards, reasonable cause; or
- (c) If a such rider is replaced by the stewards with a substitute rider for a reason other than a physical injury suffered by the rider during the time between weighing out and start of the race.

Section 10. Revised Order of Finish After Race is Declared Official. If a winning purse is forfeited through subsequent ruling of the stewards or the commission, after a race has been declared official, the winning fee shall be paid to the jockey whose mount is ultimately adjudged the winner, and the original winner shall be paid a losing mount fee.

Section 11. Duty to Fulfill Engagements. Every rider shall fulfill his or her duly scheduled riding engagements, unless excused by the stewards due to circumstances under which a jockey could not reasonably be expected to be physically present at the required time. A rider shall not be required to ride a horse he or she believes to be unsound, nor over a racing strip he or she believes to be unsafe. If the stewards find a rider's refusal to fulfill a riding engagement is based on a personal belief unwarranted by the facts and circumstances, the rider may be subject to disciplinary action.

Section 12. Presence in Jockey Room.

- (1) Each rider who has been engaged to ride in a race shall be physically present in the jockey room no later than one (1) hour prior to post time for the first race he or she is scheduled to ride, unless excused by the stewards or the clerk of scales due to circumstances under which a jockey could not reasonably be expected to ride. Upon arrival each rider shall report his or her engagements to the clerk of scales. If a rider fails for any reason to arrive in the jockey room no later than one (1) hour before post time of a race in which he or she is scheduled to ride, the clerk of scales shall so advise the stewards who may name a substitute rider and shall cause a public announcement to be made of the rider substitution prior to opening of wagering on the race.
- (2) Each rider reporting to the jockey room shall remain in the jockey room until he or she has fulfilled all riding engagements for the day, except to ride in a race, or to view the running of a race from a location approved by the stewards. While a rider is outside of the jockey room, a rider shall not have contact or communication with any person other than an owner or trainer for whom he or she is riding, a racing official, or a media

representative authorized by the stewards, until the rider has fulfilled all his riding engagements for the day.

- (3) The association shall be responsible for security of the jockey room and for excluding all persons except riders scheduled to ride on the day's program, valets, authorized attendants, racing officials, media representatives authorized by the stewards, and persons having special permission of the stewards to enter the jockey room.
- (4) Any rider intending to discontinue riding at a race meeting prior to its conclusion shall notify the stewards of his or her intent to depart after fulfilling his or her final riding engagement of the day.

Section 13. Weighing Out.

(1) Each rider engaged to ride in a race shall report to the clerk of scales for weighing out not more than one (1) hour and not less than fifteen (15) minutes before post time for each race in which he or she is engaged to ride, and when weighing out, the rider shall declare overweight, if any.

(2)

- (a) A rider shall not pass the scale with more than one (1) pound overweight, without consent of the owner or trainer of the horse he or she is engaged to ride; and
- (b) A rider shall not pass the scale with more than five (5) pounds overweight.
- (3) A horse shall not be disqualified because of overweight carried.
- (4) Riding crops, blinkers, number cloths, bridles, bits, reins, over-girth, breast collar, goggles, safety helmets, and safety vests shall not be included in a rider's weight.

Section 14. Wagering.

(1) A rider shall not:

- (a) Place a wager;
- (b) Cause a wager to be placed on his behalf;, or
- (c) Accept any ticket or winnings from a wager on any race except on his or her own mount, and except through the owner or trainer of the horse he or she is riding.
- (2) The owner or trainer placing wagers for his or her rider shall maintain a precise and complete record of all of these wagers, and the record shall be available for examination by the stewards at all times.

Section 15. Attire.

- (1) Upon leaving the jockey room to ride in any race, each rider shall be neat and clean in appearance and wear the traditional jockey attire with all jacket buttons and catches fastened.
- (2) Each jockey shall wear:
- (a) The cap and jacket racing colors registered in the name of the owner of the horse he or she is to ride;
- (b) Stock tie;
- (c) White or light breeches;
- (d) Top boots;
- (e) A safety vest and safety helmet that meet the standards established in subsections
- (4) and (5) of this section; and
- (f) A number on his or her right shoulder corresponding to his mount's number as shown on the saddle cloth and daily racing program.
- (3) The clerk of scales and attending valet shall be held jointly responsible with a rider for his neat and clean appearance and proper attire.

- (4) A jockey mounted on a horse or stable pony at a location under the jurisdiction of the commission shall wear a properly secured safety helmet at all times. If requested by a commission official, the jockey shall provide sufficient evidence that his or her helmet has a tag, stamp, or similar identifying marker indicating that it meets or exceeds one (1) of the following safety standards:
 - (a) ASTM International Standard, ASTM F1163-04a;
 - (b) British Standards, BS EN 1384:1997 or PAS 015:1999; or
 - (c) Australian/New Zealand Standard, AS/NZS 3838:2006.
- (5) A jockey mounted on a horse or stable pony at any location under the jurisdiction of the commission shall wear a safety vest at all times. If requested by a commission official, the jockey shall provide sufficient evidence that his or her safety vest has a tag, stamp, or similar identifying marker indicating that it meets or exceeds one (1) of the following safety standards:
 - (a) British Equestrian Trade Association (BETA):2000 Level 1;
 - (b) Euro Norm (EN) 13158:2000 Level 1;
 - (c) ASTM International Standard, ASTM F2681-08;
 - (d) Shoe and Allied Trade Research Association (SATRA) Jockey Vest Document M6 Issue 3; or
 - (e) Australian Racing Board (ARB) Standard 1.1998.

Section 16. Advertising.

(1) A jockey shall not wear advertising or promotional material of any kind (whether for a nonprofit or for-profit entity) on clothing within one (1) hour before or after a race, unless:

(a)

- 1. The material advertises or promotes the Jockey's Guild in the form of the picture of a jockey's boot or the picture of a wheelchair, with no additional picture or logo;
- 2. The material advertises or promotes the Permanently Disabled Jockey's Fund in the form of the pictures of its logo, with no additional picture or logo; or
- 3. The picture or logo has previously been approved by the current owner, association, and the stewards under the process established in this administrative regulation, and this approval is reflected in the commission's official records;
- (b) The material complies with the size restrictions of subsection (2)(b) of this section;
- (c) The material meets the advertising standards established in subsection (2) of this section;
- (d) Written approval by the following is submitted to the commission:
 - 1. The managing owner of the horse, or authorized agent of the managing owner;
- 2. The jockey riding the horse or the authorized agent of the jockey;
- 3. The licensed racing association, which shall grant approval if it reasonably determines the material meets the standards in subsection (2)(a) of this section; and
- 4. The stewards, who shall grant approval if they reasonably determine the material meets the standards in subsections (2)(b) and (3) of this section; and
- (e) Written approval required pursuant to subsection (1)(d) of this section is evidenced by completion and return to the commission of the Request to Wear Advertising and Promotional Materials, form KHRC-4-070-1. The form shall be completed and submitted to the stewards not later than 5 p.m. at least two (2) days prior to the day of

the race in which the advertising and promotional materials will be worn. Other forms of approval shall not be accepted by the commission.

- (2) Advertising or promotional material displayed on jockey clothing shall:
- (a) Not compete with, conflict with, or infringe upon sponsorship agreements applicable to the racing association race or to the race meet in progress; and
- (b) Comply with the following size restrictions:
- 1. A maximum of thirty-two (32) square inches on each thigh of the pants on the outer side between the hip and knee and ten (10) square inches on the rear of the pant at the waistline at the base of the spine;
- 2. A maximum of twenty-four (24) square inches on boots and leggings on the outside of each nearest the top of the boot; and
- 3. A maximum of six (6) square inches on the front center of the neck area (on a turtleneck or other undergarment).
- (3) A sponsorship shall not be permitted by a person or entity whose message, business reputation, or ongoing business activity could be considered as obscene or indecent to a reasonable person.
- (4) Any party who fails to comply with this or any other provision established in this administrative regulation shall be subject to penalties by the commission in accordance with KRS Chapter 230 and KAR Title 810.
- (5) As a condition for approval of advertising or promotional material, either the owners, the stewards, or the licensed racing association may require a personal viewing of the proposed material as it is to be displayed, to determine compliance with this section.

- (6) The sponsor of a licensed racing association race or race meeting may display advertising or promotional material on an association saddlecloth if it does not interfere with the clear visibility of the number of the horse.
- (7) Advertising content other than that approved in accordance with this administrative regulation shall not be permitted.
- (8) This administrative regulation shall not infringe upon or limit the common law rights of a racing association to eject or exclude persons, licensed or unlicensed, from association grounds, or to apply the association's internal rules regarding other forms of advertising not addressed in this or any other applicable statute or administrative regulation, if the internal rules have been previously filed with and approved by the commission or its authorized representative.

Section 17. Race Replay.

- (1) Every rider shall check the race replay list posted by the stewards in the jockey room the day after riding in a race.
- (2) The posting of the race replayfilm list shall be considered as notice to all riders whose names are listed to present themselves when designated by the stewards to view the race replay.
- (3) Any rider may be accompanied by a representative of the jockey organization of which he or she is a member in viewing the race replay or, with the stewards' permission, be represented at the viewing by his or her designated representative.

- 5. This Agreement shall be governed by and construed in accordance with the substantive law of the Commonwealth of Kentucky. Each of the parties consents to a state or federal jurisdiction located in Lexington, Kentucky as the sole and exclusive venue for any action arising out of or relating to this Agreement.
- 6. This Agreement (a) constitutes the entire agreement between the Guild and KTA with respect to its subject matter; (b) supersedes all prior written or oral discussions, understandings

and agreements between the Guild and KTA; and (c) constitutes the final and complete expression of the intent of the Guild and the KTA.

- 7. Each representative of the Guild and KTA executing this Agreement represents and warrants that he is expressly authorized to execute this Agreement and to bind his organization and its members by doing so.
- 8. Nothing in this Agreement will serve to alter or otherwise impede the Jockeys' ability to negotiate a different mount fee on an individual basis.
- 9. This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which shall constitute a single agreement. This agreement may be delivered by facsimile or email, and faxed or emailed signatures shall constitute original signatures that are binding on the parties to this agreement.

RE: PROPOSED CONDITION ON LICENSES TO CONDUCT LIVE HORSE RACING, SIMULCASTING, AND

PARI-MUTUEL WAGERING FOR 2024

KRS 230.290 states that all licenses granted under KRS Chapter 230 "shall be subject to all administrative regulations and conditions as may be from time to time prescribed by the racing commission." As a condition of licensure to conduct horse racing and pari-mutuel wagering, it is recommended that each racing association shall certify that it shall comply with certain requirements proposed in the attached.

The requirements cover the following topics: regulatory notifications, operational reporting, racing integrity requirements, and wagering integrity requirements. Highlights include the following:

- 1. Each licensed association is required to notify the Commission of any communication, report, or investigation conducted by any federal, state, or local regulatory agency that relates to the safety, integrity, or security of the association's operations, participants, or facilities.
- 2. Each licensed association shall provide to the Commission a report of purse money no later than seven (7) calendar days after the conclusion of each live race meeting.
- 3. Each licensed association shall notify the Commission if it becomes aware of a race-related wagering anomaly. An anomaly includes, but is not limited to, such incidents as:
 - a. Past posting, cancel delay, and other instances when wagering occurs after the horses have left the gate;
 - b. Off-shore and account wagering fraud; and/or
 - c. Suspected manipulation through computerized robotic wagering.

The licensure conditions have been shared with KHRC staff and the Race Dates Committee. The KHRC staff recommends approval of the proposed condition.

Kentucky Horse Racing Commission Condition of Licensure Pursuant to KRS 230.260

Pursuant to KRS 230.290(2), the Kentucky Horse Racing Commission ("KHRC") is authorized to prescribe necessary and reasonable conditions under which horse racing and pari-mutuel wagering is conducted in the Commonwealth of Kentucky. Therefore, as a condition of licensure by the KHRC to conduct horse racing and pari-mutuel wagering, each licensed association shall certify that it shall comply with the following requirements:

1. Regulatory Notifications

- a. Each licensed association shall notify the KHRC of any communication, report, or investigation conducted or to be conducted by any federal, state, or local regulatory agency that relates to the safety, integrity, or security of the licensed association's operations, its participants, facilities, or that would reasonably be deemed to affect public confidence in the licensed association. This notification includes, but is not limited to, communications, reports, or investigations involving the Thoroughbred Racing Association ("TRA"), Thoroughbred Racing Protective Bureau ("TRPB"), United States Trotting Association ("USTA"), American Quarter Horse Association ("AQHA"), Arabian Jockey Club ("AJC"), National Thoroughbred Racing Association ("NTRA"), the Horseracing Integrity and Safety Authority ("HISA"), the Horseracing Integrity and Welfare Unit ("HIWU"), or any agency relating to environmental, safety or public health matters. Notification to the KHRC shall include or be supplemented by a copy of the communication, report, or investigation within twenty-four (24) hours of receipt by the licensed association.
- b. Each licensed association shall notify the KHRC any time a member of a local, state, or federal law enforcement agency enters licensed association grounds for the purpose of questioning, investigating, or arresting a licensed individual. Such notice shall include or be supplemented by a copy of any report related to the questioning, investigation, or arrest prepared by the licensed association and/or prepared by the law enforcement agency. The report(s) shall be provided to the KHRC within twenty-four (24) hours of preparation and/or receipt by the licensed association.

2. Operational Reporting

- a. Each licensed association shall send a copy of any self-reporting document, form, or correspondence to the KHRC at the same time that the document, form, or correspondence is filed with the state or federal regulatory agency, or any other organization referenced in Requirement No. 1. The licensed association shall identify to the KHRC any information contained in submitted reports that the licensed association considers to be confidential or proprietary.
- b. Pursuant to 810 KAR 8:010 Section 20, purse money in thoroughbred, flat racing, and standardbred racing shall be paid, distributed, or made available no later than twenty-four (24) hours after notice from the Commission that a final laboratory report has been issued.
- c. Each licensed association shall provide to the KHRC a report of purse money no later than seven (7) calendar days after the conclusion of each live race meet. This report shall include the name of the licensed association, the date in which racing occurred,

the race number, purse totals attributed to regular stakes, purse totals attributed to the association, purse totals attributed to horsemen, purse totals attributed to state funds, and total purse amounts.

3. Racing Integrity Requirements

- a. Each licensed association shall record the date and time (in hours, minutes, and seconds) on all live video feeds originating from a Kentucky track. Each licensed association shall be responsible for recording (in hours, minutes, and seconds) the start/off time of each race. Further, each licensed association shall require the tote company with whom it does business to certify, and provide evidence of such certification, to the Chief State Steward or Presiding Judge of the closure time (in hours, minutes, and seconds) of the betting windows for each race. Records shall be retained for two years after the date of the race. Records shall be submitted to the KHRC upon request.
- b. Each of the timing systems mentioned in Requirement 3a. shall be synchronized with the U.S. Naval Observatory Clock at the beginning of each race day.
- c. Each licensed association offering thoroughbred racing shall require owners to deposit the fee for the administration of race-day furosemide, as permitted under Title 810 of the Kentucky Administrative Regulations, into the owner's account with the horsemen's bookkeeper by 12:00 p.m. Eastern Time on the day of the race. Failure of the owner to deposit such a fee may result in the owner being subjected to penalties, including fines or suspension. Each licensed association shall debit the owner's account for the furosemide fee to the credit of the KHRC.
- d. Each licensed association for thoroughbred racing shall abide by the safety and security requirements mandated by the Horseracing Integrity and Safety Act of 2020, as set forth in 15 U.S.C. 3051 et seq. ("HISA"). Each licensed association for any type of horse racing shall abide by all requirements set forth in KHRC statutes and regulations, to the extent that KHRC statutes and regulations are not preempted by HISA. All licensed associations shall be subject to inspection by KHRC officials and shall be required to make any repairs or improvements necessary to comply with the applicable safety and security regulations.

4. Wagering Integrity Requirements

- a. Each licensed association shall notify the KHRC if it becomes aware of a wagering anomaly related to racing conducted at that licensed association or related to a race imported for simulcast wagering at the licensed association, even if a report has not been filed with any of the organizations referenced in Requirement No. 1. The licensed association shall provide transactional data and video of the race to the KHRC. Wagering anomalies are defined as any incident that might reasonably affect the public's confidence in the licensed association's wagering pools. Such incidents include, but are not limited to:
 - i. Past posting, cancel delay, and other instances when wagering occurs after the horses have left the gate;
 - ii. Off-shore and account wagering fraud;
 - iii. Suspected manipulation through computerized robotic wagering;
 - iv. Pool odds manipulation;

- v. Quick pick or random pick malfunction;
- vi. Unusually large cancellation of wagers (especially right as the betting stops);
- vii. Outlets that are habitually late getting into the pools;
- viii. Manual merges;
- ix. Unusual payoffs;
- x. Failing to remove a scratched horse from the pools (which would then require a re-calculation of payoffs);
- xi. Re-entering a scratched horse to the pools without approval from the Stewards or Judges;
- xii. Suspicious wagering patterns;
- xiii. Totalizator or data communications malfunctions; and/or
- xiv. Substantial late ticket cancellations.

The list of wagering anomalies above is meant to be illustrative and not exclusive. It is the licensed association's responsibility to ensure that all wagering anomalies are communicated in a detailed and timely manner to the KHRC, whether by the licensed association or related vendor.

- b. Each licensed association shall ensure that the totalizator and video provider are available at least one week prior to the start of the live race meet for testing by the KHRC. Each licensed association shall ensure that the totalizator and video provider for its live meet are operating correctly at least 24 hours prior to the start of the live meet. Each licensed association shall ensure the video provider for its live meet performs its duties to the satisfaction of the KHRC, including, but not limited to, by having functional cameras and displaying all notifications timely and legibly for the wagering public.
- c. Each licensed association shall require its totalizator, video provider, and teletimer provider to share any and all racing and wagering data requested by the KHRC.
- d. Each licensed association shall post policies and procedures related to pari-mutuel wagering, including the licensed association's refund policy, on the licensed association's website. Each licensed association shall also post a notice in the racing program and a sign at the association's information window informing patrons where they can access a complete copy of the association's policies and procedures related to pari-mutuel wagering, including the association's refund policy.
- e. Each licensed association shall provide a copy of its mutuel department policies and procedures to the KHRC.
- f. Each licensed association shall have protocols in place that mandate exclusion of any receiving track's wagering pool when the licensed association cannot verify that all wagers in the receiving track's pool were received prior to the official start of the race. Copies of these protocols shall be provided to the KHRC.
- g. Each licensed association shall have protocols in place and shall publicize to its wagering patrons when, as a receiving track, it is excluded from a host track's wagering pool. These protocols shall include an immediate public announcement

- and immediate posting on the licensed association's video monitors and websites. Copies of these protocols shall be provided to the KHRC.
- h. In the event of exotic wagering hosted by another jurisdiction on a licensed association's race date, whereby a KHRC official's actions pursuant to 810 KAR 2:040 Section 5(9) or 810 KAR 2:050 may impact the outcome of the wager, the licensed association must inform the KHRC of the following information at least three (3) calendar days prior to such wagering:
 - i. Type, number, and denomination of the wager;
 - ii. The specific performance (including, but not limited to, number, type of race, etc.) and racetrack(s) involved in the wager; and
 - iii. Name and direct phone number for the person responsible for operating the wager for the host site and totalizator company.

Further, any such wager shall be included in the official race program of the licensed association with the wager for each applicable race date.


- i. Each licensed association that does business with any individual, person, or entity that offers advance deposit account wagering ("ADW") to Kentucky residents shall ensure that the ADW is licensed by the KHRC prior to doing business with that ADW.
- j. Each licensed association shall submit an electronic copy of the Kentucky Department of Revenue Forms 73A100 and 73A101 to KHRC.Reports@ky.gov no later than 4:30 p.m. on the 5th business day (excluding Saturday and Sunday) following the close of each racing week. Note that each licensed association must report its wagers, including any wagers conducted through a subsidiary, on a single return for each period.
- k. Each licensed association shall settle (and pay, as required) all wagering accounts with simulcast partners on a timely basis, in no event exceeding 60 days past any respective due date.
- I. Each licensee shall ensure sufficient printed copies of the program are made available to KHRC staff and shall provide a digital copy of the program to the KHRC via e-mail no later than six (6) hours prior to the first race of the program.
- m. All licensed associations are required to have a licensed tote employee on the premises during live racing.
- 5. Each licensed association shall submit to the KHRC a full employee list that includes the official title of the employee at the licensed association and the date of the employee's hire. This shall be submitted in a format approved by the Commission's Director of Licensing on a monthly basis, no later than the 5th business day of the month.
- 6. Each licensed association shall report to the KHRC in writing, as required by 810 KAR 3:020, Section 11, the discharge of any licensed employee within 24 hours of the event.
- 7. Each licensed association shall ensure that all vendors and vendor employees utilized for the licensed association's operations are properly licensed by the KHRC.

- 8. Each licensed association shall require that all vendors and vendor employees display a KHRC identification badge while on licensed association grounds.
- 9. All licensed associations must pay for allocated expenses of the Commission pursuant to invoice terms, as set forth in KRS 230.240(3).

All notices required to be given to the KHRC under this condition of licensure, unless otherwise stated, shall be provided to the Executive Director, Deputy Executive Director, Chief State Steward/Presiding Judge, and Director of Pari-Mutuel Wagering and Compliance via hand delivery and/or electronic mail triggering the notice requirement. In the event a licensed association does not comply with the requirements, the KHRC has the authority to assess fines and/or penalties, including, but not limited to, licensure revocation. Additional conditions may be added to an association's license at any time at the discretion of the KHRC.

RE: LICENSES TO CONDUCT LIVE HORSE RACING, SIMULCASTING, PARI-MUTUEL WAGERING, AND

SPORTS WAGERING FOR 2024

Since the previous application cycle, the Kentucky Horse Racing Commission (KHRC) has modified 810 KAR 3:010 to incorporate provisions relevant to the newly legalized sports wagering activities. This modification aims to simplify the application process for licenses related to horse racing and sports wagering by introducing a consolidated procedure. With this amendment, the KHRC now offers a unified application form, designated as the "Initial/Renewal Application for License to Conduct Live Horse Racing, Simulcasting, Pari-Mutuel Wagering, and Sports Wagering." If applicants find themselves unable to provide all obligatory information, they are required to submit an exhaustive account of such limitations, accompanied by a proposed timeline for completion, as stipulated by the KHRC.

Although the eligibility requirements for sports wagering and horse racing licenses possess certain similarities—such as financial stability, legislative compliance, and industry-specific knowledge—they also diverge in other ways. The racing license requires an initial fee of \$5,000 and an investigative fee of \$10,000, which may also apply upon license renewal, as directed by the KHRC. An entity that is not licensed as a track cannot be licensed as a sports wagering operator. The initial fee for an operator license stands at \$500,000, with a subsequent \$50,000 fee for renewals.

Applicants for both categories of licenses must submit relevant documentation that outlines their organizational structure, key personnel, and strategic plans. Applicants need to furnish details concerning significant changes to facilities, ownership shifts, and potential impacts on the Commonwealth of Kentucky. Those applying for a sports wagering license are additionally obligated to provide details on equipment and software, arrangements with third-party service providers, and internal controls related to sports wagering.

Upon approval, all license holders are required to inform the KHRC of any substantial modifications in operational methods or major shifts in circumstances. The KHRC staff may request clarification for any documentation submitted prior to or throughout the duration of the license.

As of the deadline, nine tracks have submitted applications for conducting horse racing and associated wagering activities. Of these, seven have requested a renewal of the sports wagering operator license and one has requested an initial sports wagering operator license. The following

Churchill Downs Racetrack, LLC ("Churchill Downs")

Churchill Downs has filed a renewal application related to horse racing, pari-mutuel wagering, and sports wagering operations in 2024. The company was restructured as a limited liability company in 2013 and is a wholly-owned subsidiary of Churchill Downs Incorporated. The track currently conducts thoroughbred racing, simulcasting, pari-mutuel wagering on live and historical horse racing, and sports wagering. In addition to the main track site, Churchill Downs offers wagering as Derby City Gaming located on Poplar Level Road in Louisville, Kentucky. Churchill Downs expects to launch Derby City Gaming Downtown in December 2023. This facility will offer simulcasting, parimutuel wagering on historical horse racing, and sports wagering.

Churchill Downs has requested the award of the race dates listed in the attached exhibit. The application contains a list of racing officials that will be updated prior to its live racing meets in 2024. Each of the required consent letters for simulcasting has been received from the KHBPA and KTA/KTOB, in accordance with KRS 230.377 and KRS 230.3771.

Churchill Downs conducts retail sports wagering through an agreement with Sports Information Services Limited d/b/a Kambi and has requested the renewal of its sports wagering operator license for 2024. The KHRC staff recommends approval of Churchill Downs' license to conduct live horse racing, simulcasting, pari-mutuel wagering, and sports wagering.

ECL Corbin, LLC ("Cumberland Run")

Cumberland Run has filed a renewal application related to horse racing, pari-mutuel wagering, and sports wagering operations. It was formed in 2020 as a limited liability company in Delaware and is authorized to do business in Kentucky. Cumberland Run's substantive interests are held by ECL Entertainment, LLC and Keeneland Association, Inc. Cumberland Run is conducting its 2023 racing meet at its track located in Corbin, Kentucky for the first time. The track conducts harness horse racing, simulcasting, pari-mutuel wagering on live and historical horse racing, and sports wagering. In addition to the main track site, the track has conducted wagering operations at its Williamsburg, Kentucky location.

Cumberland Run has requested the award of the race dates listed in the attached exhibit. The track will provide a list of racing officials prior to its live racing meet in 2024. The required consent letter for simulcasting has been received from the KHHA in accordance with KRS 230.377 and KRS 230.3771.

Cumberland Run conducts retail and mobile sports wagering through an agreement with Crown KY Gaming, LLC d/b/a DraftKings. It has also submitted a contract with Circa Sports KY, LLC d/b/a Circa Sportsbook. Cumberland Run has requested for a renewal of its operator license to continue conducting sports wagering in 2024.

The KHRC staff recommends approval of Cumberland Run's license to conduct live horse racing, simulcasting, pari-mutuel wagering, and sports wagering for 2024.

Ellis Entertainment, LLC ("Ellis Park")

Ellis Park has filed a renewal application related to horse racing, pari-mutuel wagering, and sports wagering. In 2022, Ellis Park was approved for 100% transfer of membership interests from Laguna Development Corporation to Churchill Downs Incorporated. Ellis Park conducts thoroughbred racing, simulcasting, pari-mutuel wagering on live and historical horse racing, and sports wagering at its

main track site. It has informed the KHRC of its plans to launch another location in Daviess County, Kentucky. This facility is expected to offer simulcasting, pari-mutuel wagering on historical horse racing, and sports wagering.

Ellis Park has requested the award of the race dates listed in the attached exhibit. The application contains a list of racing officials that will be updated prior to its live racing meet in 2024. Each of the required consent letters for simulcasting has been received from the KHBPA and KTA/KTOB, in accordance with KRS 230.377 and KRS 230.3771.

Ellis Park conducts retail sports wagering through an agreement with Sports Information Services Limited d/b/a Kambi and mobile sports wagering through Penn Sports Interactive, LLC d/b/a Barstool Sportsbook. It has requested the renewal of its sports wagering operator license for 2024. The KHRC staff recommends approval of Ellis Park's license to conduct live horse racing, simulcasting, pari-mutuel wagering, and sports wagering with the following condition related to the awarded race dates:

- Ellis Park must designate additional dates that it will conduct racing from the awarded optional dates to ensure that the live meet has at least three days of racing per meet. Ellis Park must notify the KHRC of its designation by December 31, 2023 to fulfill this condition.

Keeneland Association, Inc. ("Keeneland")

Keeneland has filed a renewal application related to horse racing and pari-mutuel wagering. It has not filed an application for a sports wagering operator's license. It was incorporated in 1935 by a group of horsemen and has been restructured several times since. Keeneland's substantive interest is held by Keeneland Trustees, Inc. The track currently conducts thoroughbred racing, simulcasting, and pari-mutuel wagering on live horse racing at its track located on Versailles Road in Lexington, Kentucky. It is also part of a joint-venture agreement related to pari-mutuel wagering on historical horse racing conducted by Lexington Trots Breeders Association, LLC. Keeneland also conducts simulcasting on leased premises at the same facility while not conducting a racing meet.

Keeneland has requested the award of the race dates listed in the attached exhibit. The track will provide an updated list of racing officials prior to its live racing meets in 2024. Each of the required consent letters for simulcasting has been received from the KHBPA and KTA/KTOB, in accordance with KRS 230.377 and KRS 230.3771.

The KHRC staff recommends approval of Keeneland's license to conduct live horse racing, simulcasting, and pari-mutuel wagering for 2024. Note that this approval, if granted, would not convey a sports wagering operator license for 2024 to Keeneland.

Kentucky Downs, LLC ("Kentucky Downs")

Kentucky Downs operates a track located in Franklin, Kentucky. It was restructured in 2018 as a limited liability company following a substantial transfer of ownership to principals of ECL Entertainment, LLC. Today, it is a wholly-owned subsidiary of ECL Entertainment, LLC and a sister company to Cumberland Run. Kentucky Downs conducts thoroughbred racing, simulcasting, and pari-mutuel wagering on live and historical horse racing at its site in Franklin, Kentucky. Additionally, the track conducts wagering operations at a facility in Bowling Green, Kentucky.

Kentucky Downs has requested the award of the race dates listed in the attached exhibit. The track will provide an updated list of racing officials prior to its live racing meet in 2024. Each of the required consent letters for simulcasting has been received from the KHBPA and KTA/KTOB, in accordance with KRS 230.377 and KRS 230.3771.

Kentucky Downs has submitted information related to an initial application to conduct sports wagering in 2024 through agreements with DraftKings and Circa Sportsbook. Circa Sportsbook will operate the retail operations. The KHRC staff recommends approval of Kentucky Downs' license to conduct live horse racing, simulcasting, pari-mutuel wagering, and sports wagering for 2024.

WKY Development, LLC ("Oak Grove")

Oak Grove was formed in 2017 as a limited liability company and is a wholly owned subsidiary of Churchill Downs, Inc. Oak Grove conducts harness racing in Oak Grove, Kentucky and offers simulcasting, pari-mutuel wagering on live and historical horse racing, and sports wagering. Oak Grove has requested the award of the race dates listed in the attached exhibit. The track will provide an updated list of racing officials prior to its live racing meet in 2024. The required consent letter for simulcasting has been received from the KHA, in accordance with KRS 230.377 and KRS 230.3771.

Oak Grove conducts retail sports wagering through an agreement with Kambi and mobile sports wagering through an agreement with FBG Enterprise OpCo, LLC d/b/a Fanatics. Oak Grove has requested renewal of its operator license to continue conducting sports wagering in 2024. The KHRC staff recommends approval of Oak Grove's license to conduct live horse racing, simulcasting, pari-mutuel wagering, and sports wagering for 2024.

Lexington Trots Breeders Association, LLC ("Red Mile")

Red Mile is a harness racetrack located in Lexington, Kentucky. Red Mile was restructured in 2000 as a limited liability company. Red Mile currently conducts simulcasting and pari-mutuel wagering on live racing at its main site located in Lexington, Kentucky. Red Mile also conducts pari-mutuel wagering on historical horse racing through a joint-venture agreement with Keeneland. Red Mile has requested the award of the race dates listed in the attached exhibit. The track will provide an updated list of racing officials prior to its live racing meet in 2024. The required consent letter for simulcasting has been received from the KHHA, in accordance with KRS 230.377 and KRS 230.3771.

Red Mile conducts retail and mobile sports wagering through an agreement with American Wagering, Inc. d/b/a Caesars Sportsbook. It has requested renewal of its operator license to continue conducting sports wagering in 2024. The KHRC staff recommends approval of Red Mile's license to conduct live horse racing, simulcasting, pari-mutuel wagering, and sports wagering for 2024.

Revolutionary Racing Kentucky, LLC ("Sandy's")

Sandy's conducts quarter horse racing and, once built, will operate a track site in Ashland, Kentucky. Until then, racing will be conducted through an agreement with Red Mile at its facility in Lexington, Kentucky. Its membership interests are held by ELS-RRKY Holdings, LLC, RRKY Acquisition, LLC and Keeneland. In October 2023, Sandy's will launch simulcasting, pari-mutuel wagering on live and historical horse racing, and sports wagering at its main site in Ashland, Kentucky. Sandy's has requested the award of the race dates listed in the attached exhibit. The required consent letter for simulcasting has been received from the KyQHA.

Sandy's is licensed to conduct retail and mobile sports wagering through an agreement with BetMGM, LLC d/b/a BetMGM and mobile sports wagering through Hillside Kentucky, LLC d/b/a Bet365. It has requested for a renewal of its operator license to continue conducting sports wagering in 2024. The KHRC staff recommends approval of Sandy's license to conduct live horse racing, simulcasting, pari-mutuel wagering, and sports wagering for 2024.

Turfway Park, LLC ("Turfway Park")

Turfway Park has filed a renewal application related to horse racing, pari-mutuel wagering, and sports wagering. It was formed as a limited liability company in 1998 and, after multiple transfers of ownership, is now a wholly owned subsidiary of Churchill Downs Incorporated. Turfway Park conducts thoroughbred racing, simulcasting, pari-mutuel wagering on live and historical horse racing, and sports wagering at its main track site. It also conducts simulcasting, pari-mutuel wagering on historical horse racing, and sports wagering at a second location in Newport, Kentucky.

Turfway Park has requested the award of the race dates listed in the attached exhibit. The application contains a list of racing officials that may be updated prior to its meet later this year. If so, this list will be carried over to its meets in 2024 unless otherwise mandated by the KHRC. Each of the required consent letters for simulcasting has been received from the KHBPA and KTA/KTOB, in accordance with KRS 230.377 and KRS 230.3771.

Turfway Park conducts retail sports wagering through an agreement with Sports Information Services Limited d/b/a Kambi and mobile sports wagering through Betfair Interactive US, LLC d/b/a FanDuel. It has requested the renewal of its sports wagering operator license for 2024. The KHRC staff recommends approval of Turfway Park's license to conduct live horse racing, simulcasting, parimutuel wagering, and sports wagering.

Date Preference System

The following date system of preference is used at Turfway Park:

Foal certificates no longer are required to be on file in the racing office to enter or start at Turfway Park; however, foal certificates must be on file to obtain a preference date and to have a horse tattooed.

Each day's overnight will list the dates of horses in and on the also-eligible list to enable trainers to see what dates are getting horses into over-filled races.

- In over-filled races, preference will be given to horses in order of their assigned preference dates, earliest date first. Horses having identical dates will be chosen by lot; however, where entry and running dates are the same, the horse with the entry date will have preference.
- 2. All horses intended for racing at Turfway Park will be assigned a preference date. A horse can have only one date at any particular time. Dates assigned will be of two types:

E-Date

This date will correspond to: (a) the date on which a horse's foal papers and name card are submitted to the Identifier (the earliest date being the day when entries are first taken for the meeting). The deadline to submit foal papers/digital foal certificates to receive a date on day of entry is 9:30 a.m. Eastern. (b) The day on which a horse is first entered if his papers are not on file with the Identifier. To qualify for the latter E-Date, a horse must have been excluded from a race that appears on the overnight or he must have been entered in a condition book race that failed to fill through insufficient entries.

R-Date

This date will correspond to the day of a horse's most recent race at Turfway Park. An R-Date will also be assigned to a horse that scratches, providing the foal papers are on file with the identifier.

- 3. A horse retains his R-Date until he receives a newer R-Date. No horse with an established R-Date may receive an E-Date. A horse whose papers are removed from the Identifier's office will lose his date and must subsequently re-establish a date in order to receive preference. A horse with an E-Date cannot receive a newer E-Date. Horses starting at another racetrack will forfeit any date they may have at Turfway Park. Additionally, horses racing at Turfway Park without foal papers on site will not retain their R-Date.
- 4. Preference dates are good for any type of race or distance (other than maiden dates).
- 5. Maiden dates will be kept separately and will not have preference in winners' races.
- 6. No E-Date will be assigned to the second choice of an un-split same-owner entry.
- 7. A horse that has been placed on a list (Veterinarian, Steward, Starter, or Paddock Judge) will lose his date and be assigned an R-Date corresponding to the day he is removed from the list.
- 8. Horses on the Also-Eligible list shall be permitted to draw into races and will be assigned post positions in the order of their dates, earliest dates first.
- 9. A horse that is a scheduled starter in a canceled race will not receive an R-Date for that race but will retain his previous date.
- 10. The draw of stake and handicap races is not subject to date preference.
- 11. Preference dates are transferred through change in ownership and changes in trainer only after the proper transfer procedures have been completed through the Stewards' Office and delivered to the Racing Secretary's Office.
- 12. Date preference rules will not supersede KHRC rules regarding preference, eligibility, or scratches.

On October 3, 2023, the KTDF Advisory Committee considered the following requests regarding Turfway Park, LLC's 2023 Holiday and 2024 Winter/Spring Race Meet:

The KTDF purse structure for the 2023 Holiday meet will consist of 20 race days beginning Wednesday, November 29th through Saturday, December 30th. The 2024 Winter/Spring meet will consist of 52 race days beginning Wednesday, January 3rd through Saturday, March 30th. Turfway Park is proposing a total of KTDF purses in the range of \$8.5 – \$9.2 million. These projections are based on a KTDF earned balance of \$220,000 at the end of their 2023 Winter/Spring Meet and additional projected earnings of \$5 million by the end of their meet with HHR wagering at Turfway Park and Newport Racing & Gaming being the primary driver. To encourage participation during the meet, Turfway Park will pay out KTDF purses through last place to all KTDF eligible horses.

To help Turfway Park fund their KTDF purses while increasing the strength of the overall Kentucky Racing Circuity, the following KTDF transfer is requested:

 WKY Development, LLC d/b/a Oak Grove requests to transfer \$3.7 million of KTDF Earnings to Turfway Park at the conclusion of Turfway's Race Meet.

Turfway Park Racing & Gaming has reviewed our purses and would like to card KTDF purses in the range of \$8.5 million to \$9.2 million for our upcoming Holiday/Winter Spring Meet(s). We have based the range on the following information:

- 1. At the end of July 2023, Turfway Park ended with a KTDF balance of approximately \$220K.
- 2. The source(s) of Turfway's KTDF to be used over this period are as follows:
 - a. Turfway Park/Newport HRM: \$5 million (HRM + \$250K live racing wagers)
 - b. Oak Grove: \$3.7 million
- 3. Our 2023 Holiday Meet will consist of 20 racing days beginning Wednesday, November 29th and ending Saturday, December 31st, 2023. Our 2024 Winter/Spring meet with consist of 52 racing days. The 2024 Winter/Spring Meet begins on January 1st 2024 and ending on March 30th, 2024.
- 4. We anticipate that KTDF will be approximately 49% of offered purses. Of the requested KTDF allotment, we anticipate the following payouts:
 - a. ALW, AOC, SMSW, MDN: approximately 63% of the KTDF allotment
 - b. BCL, CLM, MCL, STR, WMC: approximately 21% of the KTDF allotment; and
 - c. Stakes: approximately 16% of the KTDF allotment
- 5. For December 2023 through March 2024, we are assuming a KTDF payout percentage of 95% with anticipated KTDF disbursements of \$9.2 million which is \$9.03 million. We paid out \$8.8 million last year over the same period.
- 6. To encourage participation during the Fall Meet, we are again planning to pay KTDF purses from first to last to all eligible horses.

THE KENTUCKY THOROUGHBRED DEVELOPMENT FUND (KTDF)

Horsemen with Kentucky-sired Kentucky breds have over \$30 million more in purse money to run for in for designated stakes, handicap, allowance, non-claiming maiden races, and claiming races contested at licensed Thoroughbred race meetings in Kentucky.

Eligible races can be readily recognized in the stakes and condition books by the Kentucky Thoroughbred Development Fund seal, which will appear next to each race in the stakes and condition books.

In accordance with KRS 230.400(5)(d), it is mandatory for a horse to be registered prior to time of entry to be eligible to participate in the distribution of Kentucky Thoroughbred Development Fund monies. Registration is only complete once the application is approved and payment has been received.

All horses of racing age that are both Kentucky-bred and sired by a Kentucky stallion which stood in Kentucky the entire breeding season the year the horse was conceived are eligible to be registered. Owners of horses of racing age are responsible for registering their horses. Stallion owners are responsible for registering their stallions.

WAGERING CATALOG

In accordance with KRS 230.805(2), the Kentucky Horse Racing Commission (KHRC) is required to promulgate administrative regulations to establish standards for the conduct of Sports Wagering. As stated in 809 KAR 10:002 Section 2, a licensee shall not offer sports wagering that "has not been approved by the racing commission". Critical components of each system for sports wagering are the sporting events upon which sports wagers may be conducted.

The Kentucky Sports Wagering Advisory Council (Council) convened on August 31, 2023 to review the initial Kentucky Sports Wagering Catalog (Catalog). The Council endorsed the Catalog, and recommended ratification by the KHRC.

Further petition for additions to the Kentucky Sports Wagering Catalog (Catalog) presented on August 31, 2023 were considered by the KHRC, each requiring a separate application and supporting exhibits which may be viewed on the KHRC website (khrc.ky.gov). In reviewing the sporting events and sports governing bodies submitted through September 18, 2023, the KHRC recommended the following additions to the Catalog pursuant to the suitability requirements set forth in 810 KAR 10:002.

- Formula 1 Racing
- NRL (National Rugby League- Australia)
- PFL (Professional Fighters League- MMA)
- Bellator (MMA)
- Universal Tennis League

The Kentucky Sports Wagering Advisory Council (Council) convened on September 21, 2023 to review the proposed additions to the Kentucky Sports Wagering Catalog (Catalog). The Council endorsed the Catalog additions, and recommended ratification by the KHRC.

Pursuant to KRS 230.230(1)(a),(e) KHRC Executive Director Jamie Eads granted conditional approval of the initial Kentucky Sports Wagering Catalog along with the five (5) additions presented on September 21, 2023. pending or subject to ratification of the Commission. KHRC staff recommends ratification for both of Executive Director Eads' approvals.

LABORATORIES SUBMISSION CRITERIA

ITLs must provide a range of information, including corporate details, such as the name of the ITL, trade names, federal identification numbers, contact information, and the designation of a liaison who will serve as the KHRC's point of contact. ITLs are also required to provide a comprehensive description of their business, including the type of business, any public trading status, incorporation documents, and details of any financial or ownership interests with other entities in the field, among other points. Specifically, if the ITL has any interest or relationship with a track, service provider, occupational licensee, or prospective applicant for those licenses, it must be disclosed. Ownership structures must be clearly depicted through a flowchart. Details on litigation and regulatory background are also required to help provide a complete picture of the ITLs' operations.

These disclosures are critical for ensuring financial independence, which is one of the key criteria for the selection of approved ITLs. Please refer to the attached document for a detailed list of specific questions and requests related to this process.

On September 21, 2023 the Sports Wagering Advisory Council convened to consider a motion to recommend these criteria. Upon review, the Council did so move to recommend ratification by the KHRC.

Pursuant to KRS 230.300(11), KHRC Executive Director Jamie Eads granted conditional approval of these additions to the Catalog, pending or subject to ratification of the Commission. KHRC staff recommends ratification of Executive Director Eads' approval.

- 5. Copies of documented policies, systems, programs, procedures, and instructions to assure the quality of test results;
- 6. Copies of all test scripts to be used for testing against the applicable Kentucky statutes, regulations, standards, and policies; and
- 7. A statement signed by the Applicant (or its designee) that:
 - The information being provided to the Commission is accurate and complete;
 - The applicant agrees to cooperate with all requests, inquiries, or investigations of the Commission; and
 - The applicant acknowledges that the Commission shall retain jurisdiction over the independent testing laboratory in any matter involving a sports wagering system.
