AUGUST 31, 2012 KENTUCKY HORSE RACING COMMISSION ADVISORY

Governor Steve Beshear has overridden the finding of the legislature's Interim Joint Committee of Licensing and Occupations. The Governor's action means that the below regulations become effective Aug. 31, 2012. In order to provide a smooth transition and avoid confusion, the provisions of the below regulations shall be implemented on **Tuesday, Sep. 4, 2012**. However, the provision requiring furosemide to be administered by a KHRC veterinarian shall be implemented on Friday, Oct. 5, 2012, opening day of Keeneland's fall race meeting.
