1<sup>st</sup> RACE Voided claim - owner not licensed

2<sup>nd</sup> RACE #6 "Serpentine" BLED and was eased. The horse was placed on the See State Vet list.

#6 "Expressed" (Samuel Bermudez) was a late scratch from the post parade on the advice of the KHRC veterinarian.

A Stewards Inquiry was posted involving #7 "Sacred River" (Gerardo Corrales) when he unseated his rider at the start. After reviewing the race replay and interviewing the starter, the stewards determined that the horse reared and unseated the rider at the break, and that the starting gate door opened properly and the horse was not restrained by the assistant starter. Because the horse was not precluded from obtaining a fair start, there was no action taken and the race was posted official.

5<sup>th</sup> RACE Program correction: #11 "Devious Stares" was mistakenly not listed to race with Lasix. The error was discovered and the horse was permitted to receive the medication. The change was posted and announced prior to the opening of wagering.

6<sup>th</sup> RACE Program correction: #1 "Rising Heat" was mistakenly not listed to race with Lasix. The error was discovered and the horse was permitted to receive the medication. The change was posted and announced prior to the opening of wagering.
