5th RACE Program correction - #3 "Enzi" was mistakenly listed in the program to race with Lasix. The error was caught in a timely manner and the horse was permitted to race without the medication. The correction was posted and announced prior to the opening of wagering.

9th RACE A Stewards Inquiry was posted involving the start of #9 "Vivis In Front" (Rogelio Miranda) after the horse broke awkwardly and unseated his rider. After reviewing the race replay and interviewing the starter, the stewards determined that the horse broke through the gate just prior to the start and the assistant starter was pulling him back in place when the rest of the field was dispatched. Miranda was unseated and heroically held onto the horse until the outriders could assist.

Because it was determined that the horse had been precluded from obtaining a fair start, he was declared a NON-STARTER by the stewards. The mutuels department made the proper refunds.
