1<sup>st</sup> RACE A Stewards Inquiry was posted involving the start of #12 "Silky Warrior (IRE)" (Colby Hernandez). After reviewing the race replay and interviewing the starter, the stewards determined that the horse broke through the gate prior to the start and was being pulled back by the rider when the field was dispatched. The stewards declared the horse a NON-STARTER. The mutuels department made the proper refunds.

5<sup>th</sup> RACE A Stewards Inquiry was posted involving second place #3 "Danner" (Joseph Rocco, Jr.) and third place #7 "Bold at Midnight" (Fernando De La Cruz) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #3 drifted out repeatedly in the stretch and impeded the progress of #7. For the interference #3 was disqualified and placed third, behind #7. Official order of finish: 2-7-3-4
