TEST: 1<sup>st</sup> 2 & 9 (C 6), 2<sup>nd</sup> 1 & 7, 3<sup>rd</sup> 5 & 8, 4<sup>th</sup> 1 & 12, 5<sup>th</sup> 5 & 10, 6<sup>th</sup> 12 & 13, 7<sup>th</sup> 7 & 8, 8<sup>th</sup> 9 & 11.

1<sup>st</sup> RACE CLEAR

2<sup>nd</sup> RACE #6 "Maxed Up" (Johnathon Curtsinger) was distanced for the third time in three lifetime starts and was placed on the Stewards' List. The horse will no longer be permitted to race in Kentucky.

3<sup>rd</sup> RACE CLEAR

4<sup>th</sup> RACE An objection was lodged by the rider of third place #10 "Sargeant Barger" (Joseph Ramos) alleging interference by the rider of the unofficial winner #12 "Hatch" (Chris Landeros) at the start. After reviewing the race replay and interviewing the riders, the stewards determined that there was no interference and the race was posted official.

5<sup>th</sup> RACE CLEAR

6<sup>th</sup> RACE Program Correction: #13 "First Squadron" was mistakenly listed to race with Lasix. The error was discovered and the horse was permitted to race without the medication. The correction was posted and announced prior to the opening of wagering.

7<sup>th</sup> RACE #4 "Beam of Light" (Joseph Talamo) lunged at the start and unseated her rider. The horse ran with the field and was caught by the outrider after the race without incident. Both rider and horse escaped injury.

8<sup>th</sup> RACE Voided claim - no owner listed

RULING ISSUED:

#22-0002 - Owner/Trainer Joe Sharp - All penalties relating to Joe Sharp in rulings #21-0006, #21-0008 and #21-0010 through #21-0012 are vacated.
