2nd RACE #6 "Maxed Up" (Johnathon Curtsinger) was distanced for the third time in three lifetime starts and was placed on the Stewards' List. The horse will no longer be permitted to race in Kentucky.

3rd RACE CLEAR

4th RACE An objection was lodged by the rider of third place #10 "Sargeant Barger" (Joseph Ramos) allingini interference by the rider of the unofficial winner #12 "Hatch" (Chris Landeros) at the start . After reviewing the race replay and interviewing the riders, the stewards determined that there was no interference and the race was posted official

5th RACE CLEAR

6th RACE Program Correction: #13 "First Squadron" was mistakenly listed to race with Lasix. The error was discovered and the horse was permitted to race without the medication. The correction was posted and announced prior to the opening of wagering.

7th RACE #4 "Beam of Light" (Joseph Talamo) lunged at the start and unseated her rider. The horse ran with the field and was caught by the outrider after the race without incident. Both rider and horse escaped injury.
