1st RACE Program correction - #9 "Celestial Harmony" was mistakenly listed in the program to race with Lasix. The error was caught in a timely manner and the horse was permitted to race without the medication. The correction was posted and announced prior to the opening of wagering.

4th RACE #9 "Brooklyn Can Dance" (Emmanuel Esquivel) popped the front doors open but was held in place by the assistant starter and the rider stayed aboard. The front doors were closed and the start was without incident.

5th RACE CLEAR

6th RACE #6 "Multitask" (Walter A. Rodriguez) broke through the gate prior to the start, but the rider stayed aboard. The horse was examined and approved by the KHRG veterinarian, reloaded, and the start was without incident.

9th RACE An objection was lodged by the rider of third place #8 "Street Style" (Alex Achard) alleging interference by the rider of the unofficial winner #10 "Penitent" (Jose Ramos Gutierrez) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #8 lacked room while between horses. There was no change in the order of finish and the race was posted official.
