After reviewing the race replay, the stewards determined that #9 and the unofficial winner #3 "Love Knicks Hart" (Gabriel Saez) exchanged bumps at the finish line prior to the filly falling. "Tikihut" escaped injury. Beschizza was transported to the hospital for evaluation.

7<sup>th</sup> RACE #6 "American Bear" unseated his rider in the post parade, ran loose, and was extremely fractious until he was finally captured by the outriders. The horse was scratched by the stewards. The rider escaped injury.
