A Stewards Inquiry was posted involving the stretch and in addition, 2 objections were lodged. The rider of third place #1 "Tale of Kitten" (Gerardo Corrales) alleged interference by the rider of the unofficial winner #2 "Miss Magdalena" (Agustin Gomez) in the stretch, and the rider of fourth place #12 "Joyful Praise" (Santiago Gonzalez) alleged interference by the rider of third place #1. After reviewing the race replay and interviewing the riders, the stewards determined that #1 came out in the stretch and caused #12 to check sharply and lose momentum. For the interference #1 was disqualified and placed fourth behind #12.
