7th RACE #6 "Slang" (Luan Machado) was injured in the post parade and was a late scratch on the advice of the KHRG veterinarian. The filly, who had gotten stuck halfway over the outside rail, required assistance from the KHRG veterinarians, Turfway Park gate crew and outriders. There was a 10 minute delay while the horse was removed from the rail and transported off the track in the horse ambulance. "Slang" was placed on the See State Vet list. The late scratch reduced the field to five, necessitating the cancellation of the Superfecta. The mutuels department made the proper refunds.
