RACING WAS CANCELLED AFTER RACE 5 DUE TO WEATHER CONCERNS (DROPPING TEMPERATURES AND INCREASED WIND CHILL)

1<sup>st</sup> RACE Program correction - #9 "Lipstick N Lashes" was mistakenly listed in the program to race with Lasix. The error was caught in a timely manner and the horse was permitted to race without the medication. The correction was posted and announced prior to the opening of wagering.
