1st RACE Voided claim - incorrect date

A Stewards Inquiry was posted when #13 "Berlinwin" (Gabriel Saez) unseated her rider at the start. After reviewing the race replay, the stewards determined that #13 had stumbled and unseated Saez, and that no rival had been involved. The horse was considered a starter, a claim that had been submitted for the horse was considered valid, and the race was posted official. The filly ran with the field and was caught without incident. Saez escaped injury. Ultimately, the claim was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
