RACE The claim of #10 "Crazy Face" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

- RACE #1 "Toffee" (Chris Landeros) bolted leaving the 1/4 pole and finished fifth. The incident caused sixth place #7 "Girls House" (Santo Sanjur), seventh place #2 "Stupendous" (Julio Felix) and ninth (last) place #6 "Honeytown" (Luan Machado) to check sharply and lose all momentum. For the interference, #1 was disqualified and placed ninth (last). Because all of the affected horses finished off the board and the posted top four finishers were not involved, the stewards made the race official before conducting their inquiry into the incident and determining the extent of the disqualification of #1.
- RACE #8 "Rare N Ready" (Julio Felix) was a late scratch from the post parade on the advice of the KHRC veterinarian.
- RACE An objection was lodged by the rider of third place #3 "Renaissance (IRE) (Walter A. Rodriguez) alleging interference by the rider of the unofficial winner #10 "Winward Flo" (Julio Felix) approaching the finish. After reviewing the race replay and interviewing the riders, the stewards found insufficient evidence to warrant a disqualification and the race was posted official.
