5th RACE #4 "Aerator" (Santiago Gonzalez) was pulled up abruptly near the 7/8 pole and required the assistance of the KHRC veterinarians and the horse ambulance. It was reported that the horse had suffered a catastrophic injury to his left foreleg and he was humanely euthanized.
