1st RACE #6 "Royal Kitten" was a late scratch by the stewards when he got loose in the paddock and ran through the surrounding temporary fence. The horse was captured by the outriders who were chasing him on foot over the large mound of dirt and debris that was formerly the grandstand.

#10 "Mi Sandia" (Edgar Morales) broke through the gate prior to the start but the rider stayed aboard. The horse was caught, examined by the KHRC veterinarian and reloaded. The start was without incident.
