In addition, an objection was lodged by the trainer (Kenneth Miller) of second place #4 "Tricolour" (Rafael M. Hernandez) alleging interference by the rider of the unofficial winner, #7 "Tuskegee Cat" (Jose Nava-Marin) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence to warrant a disqualification relating to either objection and the race was posted official.
