1st RACE CLEAR

2nd RACE There was a 25 minute delay when, as the field approached the starting gate, the gate crew discovered an issue with the closing mechanism on the #10 stall door. The starter determined that the issue could not be corrected and notified the stewards that it would be necessary to switch to the backup gate. During the delay the horses were returned to the paddock and riders dismounted. The horses were remounted and the eventual start using the replacement gate was without incident.

#9 "Derby Express" finished fifth and BLED

3rd RACE CLEAR

4th RACE An objection was lodged by the rider of third place #1 "Jimmys Lifestyle" (Gerardo Corrales) alleging interference by the rider of second place #4 "I Prowl Alone" (Santiago Gonzalez) in the stretch. After reviewing the race replay and interviewing the riders the stewards determined that the slight contact that occurred as #4 came out approaching the wire did not warrant a disqualification and the race was posted official.

5th RACE An objection was lodged by the trainer (Eddie Kennell) of third place #7 "Cuzzwuzzy" (Deshawn Parker) alleging interference by the rider of the winner #4 "Song of Innocence" (Chris Landeros) near the wire. After reviewing the race replay and interviewing the riders, the stewards determined that the sudden change in motion of #7 was not caused by interference, but rather the horse jumped the finish line light that was across the track. There was no change in the order of finish and the race was posted official.
