An objection was lodged by the rider of eighth place #5 "Tag Team" (Gerardo Corrales) alleging interference by the rider of the unofficial winner #3 "Crickenberger" (Walter Rodriguez) near the 3/8 pole. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence to warrant disqualification and the race was posted official.

RACE A Stewards Inquiry was posted when #9 "Veecation" (Victor Lebron) unseated his rider in the stretch. After reviewing the race replay and interviewing the rider of the unofficial winner #4 "Caladium" (Adam Beschizza), the stewards determined that #4 yeered in the stretch and caused #9 to clip heels and unseat her rider. For the interference, #4 was disqualified and placed last. Official order of finish: 5-3-13-6-7
