RACE An objection was lodged by the rider of fourth place #4 "A Real Hero" (Walter Rodriguez) alleging interference by the rider of second place #5 "Texas Magic" (Emmanuel Esquivel) in deep stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #5 did angle out in front of #4 approaching the finish, but was clear. There was no change in the order of finish and the race was posted official.

RACE An objection was lodged by the rider of second place #10 "Hurricane Debbie" (Gerardo Corrales) alleging interference by the rider of the unofficial winner, #5 "Jill Jitterbug" (Emmanuel Esquivel) in deep stretch. After reviewing the race replay and interviewing the riders, the stewards determined that the rider of #5 had an exaggerated reaction to #5 crossing his path at the finish line. There was no change in the order of finish and the race was posted official.

RACE #9 "Miss Sovelia" was injured in the paddock and was a late scratch on the advice of the KHRC veterinarian.
