2nd RACE A Stewards Inquiry was posted when #3 "Sand Mountain" (Alvin Ortiz) fell and unseated his rider while between horses and nearing the 1/4 pole. After reviewing the race replay and interviewing several riders, the stewards determined that the rider of #3 was in the process of taking back out of the tight spot when the incident occurred. There was insufficient evidence to warrant a disqualification and the race was posted official. Jockey Alvin Ortiz was transported to the hospital and reported to have suffered a fractured leg. The horse escaped injury.
