RACE #1 "Crankshaft" (Santiago Gonzalez) popped the front door of the gate open, but was held in place by the assistant starter and the rider stayed aboard. The door was closed and the start was without incident.

2<sup>nd</sup> RACE Voided claim - owner not licensed

A Stewards Inquiry was posted involving the stretch. After reviewing the race replay and interviewing the riders of second place #5 "Tiz Our Turn" (Joseph Rocco, Jr.) and third place #2 "Wile E Peyote" (Santiago Gonzalez), the stewards determined that #5 drifted out in the stretch and carried #2 out while making contact several times. For the interference, #5 was disqualified and placed third, behind #2. Official order of finish: 1-2-5-8

The claim of #1 "Happy Camper"" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

#9 "Lemonadeatthelatch" (Santiago Gonzalez) was pulled up near the 3/8 pole and required the assistance of the KHRC veterinarians and the horse ambulance. Veterinary report is pending.
