After reviewing the race replay and interviewing the riders, the stewards determined that there was contact between the two horses as #1 attempted to go around a horse and #7 attempted to hold him in place, but that the contact was mutual. There was no change in the order of finish and the race was posted official.

5<sup>th</sup> RACE #1 "Shartie" (Emmanuel Esquivel) was pulled up in the stretch and required the assistance of the KHRC veterinarians and the horse ambulance. His connections transported him to a Lexington clinic for evaluation and after diagnostics were performed the horse was humanely euthanized.
