8<sup>th</sup> RACE A Stewards Inquiry was posted involving several horses near the 1/4 pole and in addition an objection was lodged by the rider of tenth place #7 "Rathrbluckythngood" (Jermaine Bridgmohan) alleging interference by the riders of both second plac #10 "Barton Hall" (Julie Burke) and the unofficial winner #1 "Honey Bourbon" (Santiago Gonzalez) near the 1/4 pole. There was also an objection lodged by the trainer of #7 (Jason Barkley) alleging interference by #1. After reviewing the race replay and interviewing the riders the stewards determined that #7 and #10 were going for the same opening between horses with #10 being the first to the spot. #7 then lacked room and checked. #1 on the outside maintained a straight course. There was no action taken and the race was posted official.


#9 "Three Birds" (Gerardo Corrales) was pulled up at the 5 1/2 pole and required the assistance of the KHRC veterinarians and the horse ambulance. It was reported that the filly, who was released to the care of the private veterinarian, had returned lame and was placed on the See State Vet list.
