In addition there were 2 rider objections. #2 "Laddie Boy" (Mitchell Murrill) lodged an objection alleging interference by both the riders of second place #6 "News Box" (Declan Cannon) and the unofficial winner #1 "Coworker" (James Graham). Also alleging interference by both the #6 and #1 was fourth place #7 "Woopigsooie" (Rafael Bejarano). After reviewing the race replay and interviewing the riders, there were 2 separate disqualifications. Both rider objections were disallowed. As a result of the Stewards Inquiry and for interfering with #5, #2 was disqualified from third and placed sixth. Also, #6 was disqualified from second for interfering with #2 and was placed behind him. Official order of finish: 1-7-4-5-2-6-3
