5th RACE #3 "Samarita" (Israel Hernandez) was injured in the paddock and was a late scratch on the advice of the KHRG veterinarian.

6th RACE #2 "Gotta Lotta Tempo" (Tyler Gaffalione) fell and unseated her rider near the 3/16 pole and required the assistance of the KHRG veterinarians and the horse ambulance. It was determined that the filly had suffered a catastrophic injury to her right foreleg and she was humanely euthanized. The rider escaped serious injury.

7th RACE An objection was lodged by the rider of second place #11 "Fleetingly" (Flavien Prat) alleging interference by the rider of the unofficial winner #9 "Unmerited Favor" (Jose L. Ortiz) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #11 steadied slightly while in tight quarters between horses. There was no change in the order of finish and the race was posted official.

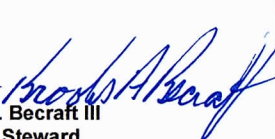
