7<sup>th</sup> RACE An objection was lodged by the rider of fifth place #7 "Tap Gold" (Edgar Morales) alleging interference by the rider of the unofficial winner #5 "Cousin Larry" (Gabriel Saez) near the 1/4 pole. After reviewing the race replay and interviewing the riders the stewards determined that there was no interference and that the #7 lacked room while trying several routes. There was no change in the order of finish and the race was posted official.

9th RACE A Stewards Inquiry was posted involving the start of #11 "Sound Money" (Tyler Gaffalione). After reviewing the race replay and interviewing the starter and rider, the stewards determined that the starting gate doors failed to open properly and timely due to a mechanical failure, precluding #11 from obtaining a fair start. #11 "Sound Money" was declared a non-starter by the stewards and all proper refunds were made through the mutual department.
