1st RACE #8 "Cielo" (Flavien Prat) fell and unseated his rider near the 1/4 pole and required the assistance of the KHRG veterinarians and the horse ambulance. It was determined that the colt had suffered a catastrophic injury to his left foreleg and he was humanely euthanized. The rider escaped serious injury.

2nd RACE The claim of #3 "Geno's Myth" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
