INCIDENTS/INQUIRIES/OBJECTIONS

- **Race 2** → Due to 2 scratches the Superfecta Wagering was cancelled due to only 5 Horses racing.
- **Race 5** → #5 Alpha Blue Chip was lame post-race in the state test barn and was placed on the vets list 14 days & must qualify.
- **Race 7** → #3 Fearless Bettor was DNF due to A-Fib. State Vet inspected the horse and placed #3 Fearless Bettor on the vets lists 14 days & must qualify.
- **Race 10** → #3 Bricco did run for an extended period of time after the top of the stretch violating the breaking rule and was 5th placed 6th by the Board of Judges.
- **Race 12** → #4 Country Glide was scratched by the State Vet in the post parade lame. Also being placed on the Vets List - 14 Days & must qualify.
