TEST: 1<sup>st</sup> 1 & 5, 2<sup>nd</sup> 6 & 8 (C 3-voided), 3<sup>rd</sup> 7 & 8 (C 4), 4<sup>th</sup> 7 & 10, 5<sup>th</sup> 4 & 9, 6<sup>th</sup> 1 & 2 (C 3 & 5), 7<sup>th</sup> 3 & 4, 8<sup>th</sup> 5 & 7, 9<sup>th</sup> 4 & 5, 10<sup>th</sup> 9 & 10.

DAY: 5

1<sup>st</sup> RACE CLEAR

2<sup>nd</sup> RACE #3 "Off the Clock" (Gerardo Corrales) was pulled up abruptly near the 3/8 pole and required the assistance of the KHRC veterinarians and the horse ambulance. It was later determined that the horse had suffered a catastrophic injury to his left foreleg and he was humanely euthanized. A claim that had been submitted for the horse was voided.

3<sup>rd</sup> RACE An objection was lodged by the rider of second place #6 "Miss Tappy Toes" (Corey Lanerie) alleging interference by the rider of the unofficial winner #7 "Jackie's Love" (Isaias Ayala). After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence to warrant a disqualification and the race was posted official.

4<sup>th</sup> RACE #5 "Chiquita Reina" (Gerardo Corrales) was injured in the paddock and was a late scratch on the advice of the KHRC veterinarian.

5<sup>th</sup> RACE A Stewards Inquiry was posted involving an incident in the first turn when #5 "Agapee Mou" (Vincent Cheminaud) bolted suddenly and collided with #10 Zverev" (Cristian Torres). It was determined that there had been an equipment failure (broken stirrup) on #5 that led to the incident. Neither horse or rider suffered an injury. No action was taken and the race was posted official.

6<sup>th</sup> RACE #6 "Rungius" (Adam Beschizza) finished second and required the assistance of the KHRC veterinarians and the horse ambulance. It was reported that the horse had suffered a post-race heatstroke and he was placed on the See Vet list.
