

The rider dismounted and carefully led the filly to the outside rail to avoid a problem with the rest of the field being able to finish the race. The KHRC veterinarians quickly attended to the filly and along with the rider, kept her quiet and tried to shield her from seeing the approaching horses cross the finish line. Due to this quick thinking and action, the rest of the field was able to finish the race without incident. The injured filly was then loaded into the horse ambulance and taken to her barn for evaluation by the private vet, whose report is pending.
