1st RACE #8 "Apollo Rising" (Flavien Prat), the winner, suffered a post-race heatstroke and required the assistance of the KHRC veterinarians and the horse ambulance. A claim that had been submitted for the horse was voided. A blood sample was drawn and the horse was excused from the test barn.

2nd RACE #2 "McAvoy" (Declan Carroll) was a late scratch from the post parade on the advice of the KHRC veterinarian.

8th RACE #14 "Foreseen" (Julien Leparoux) was injured in the paddock and was a late scratch on the advice of the KHRC veterinarian.


#2 "Enigmatic" (Florent Geroux) was injured in the starting gate and was a late scratch on the advice of the KHRC veterinarian.
