1st RACE The claim of #9 "Derrick" was voided pursuant to HISA Rule #2262 when the horse BLED and was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

2nd RACE CLEAR

3rd RACE An objection was lodged by the rider of third place #1 "Miss Foxann" (Isaias Ayala) alleging interference by the rider of the unofficial winner #5 "Yolanda Who" (Edgar Morales) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that the slight contact was mutual. There was no change in the order of finish and the race was posted official.

The claim of #4 "Honor Gold" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
